


A Lease ~~Agreement~~ over, under and across part of the Southeast Quarter of the Southwest Quarter of Section 34, Township 07 North, Range 09 East, City of Madison, Dane County, Wisconsin. Said Lease Agreement more fully described as follows:

Commencing at the south quarter corner of said Section 34; thence North 89 degrees 24 minutes 27 seconds West, along the south line of the southwest quarter of said Section 34, a distance of 1021.14 feet; thence North 00 degrees 35 minutes 33 seconds East, 833.62 feet to the southeasterly line of Certified Survey Map (C.S.M.) Number 2043, recorded as Document Number 1472778, a point of curvature and the point of beginning of this Lease Agreement; thence continuing 405.00 feet along said southeasterly line of C.S.M. 2043 and the arc of a curve to the right having a radius of 5779.65 feet and a chord bearing North 42 degrees 39 minutes 33 seconds East, 404.91 feet to the northeast corner of said C.S.M. 2043; thence South 89 degrees 02 minutes 21 seconds East, 20.69 feet; thence South 45 degrees 19 minutes 41 seconds East, 17.06 feet; thence South 44 degrees 18 minutes 33 seconds West, 100.27 feet; thence South 88 degrees 51 minutes 34 seconds West, 16.94 feet; thence South 43 degrees 18 minutes 02 seconds West, 78.40 feet; thence South 02 degrees 08 minutes 21 seconds East, 16.97 feet; thence South 41 degrees 43 minutes 26 seconds West, 214.07 feet; thence North 50 degrees 17 minutes 24 seconds West, 32.00 feet to the point of beginning. Said Lease Agreement contains approximately 12,347 square feet or 0.283 acres, more or less.
