I am writing to you on behalf of the Global Conservation Group regarding Chick-fil-A's request for permit approvals at the address of 423 S. Gammon Road.

The City of Madison has always been a leader when it comes to supporting diversity and kindness of its citizens, however, allowing Chick-fil-A to construct an establishment in Madison would be turning our backs on a portion of our community; our LGBT (lesbian, gay, bisexual and transgender) friends, family and neighbors. I think it's important that the city sends a message that we want business here ... but what we can't have and don't want are businesses that have discriminatory roles.

Chicago and Boston both denied similar permit requests made by Chick-fil-A. In fact, Chicago Mayor Rahm Emanuel said "They disrespect our fellow neighbors and residents. This would be a bad investment, since it would be empty."
