

## Segredo's Change of Licensed Premises Application & 18+ Entertainment License Renewal Request: Some Context

Our purpose in submitting a Change of Licensed Premises application is to formally request ALRC permission to continue to "temporarily" cover our 4 bowling lanes as a dance floor along with space for a movable, non-permanent dj &/or band platform. Unfortunately, despite spending nearly 18 months and tens of thousands of dollars on resolving this issue - we don't see any short/medium-term technologically feasible or cost effective solution to address the City's Building Inspection Division objection to the lack of Underwriters Laboratory certification of our Brazilian-manufactured bowling equipment. This objection (see attached letter dated 8/12/2010 addressed to Segredo's landlords threatening legal action), and not the lack of commercial success of our original concept, forced us to disconnect the bowling system power and cover the lanes.

The crux of the matter is that UL as an independent testing organization (not a government entity) does not currently extend reciprocity to the Brazilian equivalent of UL that it accepted in many other parts of the world (including the European Union) and the cost of obtaining certification for a customized UL compliant Segredo installation would end up costing more than our entire initial acquisition/ installation investment in the bowling system. Our hope is that at some point in the future, UL's reciprocity approach will change and we will be able to return the bowling lanes to service while still being able to occasionally cover them for dance parties/fashion shows/bands/etc. which was our original plan. As part of this Change of Licensed Premises application we are also necessarily requesting a capacity increase to allow the space previously used as bowling lanes to be used by customers as a dance floor, and our capacity request is only 20 patrons more than was previously approved for use by the prior licensed establishment (Madison Avenue) in this same 11,000+sq ft (extremely large) space that has the potential of accommodating just under 1,000 patrons depending on the business model/usage.

We would make three points in support of our application:

1) Whether the focal point of the main room space is used by 24 bowlers or 100+ dancers, over the last 2 years Segredo has been operating in the 600 block of University Avenue as exactly the type of entertainment venue (vs. a bar devoted to vertical drinking space) that the City is trying to encourage. In fact, while most people aren't aware of it - this semester we have probably been the 3<sup>rd</sup> busiest music venue in downtown Madison (behind only the Overture center and the Majestic) despite the tough economy (see the attached Segredo show flyer for some of this semester's larger shows).

- 2) Two years ago we chose to locate Segredo in Madison because we felt strongly about our ability to prove that a large capacity entertainment venue WITH AN 18+ LICENSE could be successfully operated near campus. Given our track record over the past twenty four months, and with a huge amount of effort/money on our part, we have earned the respect and support of the Madison Police Department based upon our operating philosophy & practices (see attached "Before" and "After" graphics depicting Madison Police Call For Service statistics for Madison Avenue prior to our ownership and in Segredo's first year of operation). Every weekend, month in and month out, we offer our customers (whether they are 18+ OR 21+) a fun and safe place to see great entertainment in a beautiful setting. And we keep getting better. Most residents would probably agree that the City needs more 18+ entertainment options for our young people. We like to think we are helping that cause.
- 3) We understand that there are some residents of the City who do not believe ANY increase in licensed establishment capacity should be permitted downtown because of alcohol abuse issues. We understand why people might feel this way. However, I would offer three comments for your consideration a) the capacity increase we are asking for is overwhelmingly going to be used as dancing space, not drinking space b) given our 18+ Entertainment License, many of the additional people we might allow into Segredo with the incremental capacity increase won't be drinking and c) our view is that while it's very important for the ALRC to firmly punish bad operators, it's also very important to reward good, solid operators like Segredo for their efforts. We hope you find this capacity increase a reasonable request we are making under the circumstances.

With respect to the 18+ Entertainment License, in the process of preparing our Change of Licensed Premises application these past few weeks, it was brought to our attention that Segredo's most recent 18+ Entertainment License was not renewed at the last renewal cycle. Neither the City Clerk's office nor Segredo understands exactly why that omission occurred, but as soon as we found out what the situation was - we indicated that we would re-apply for the license at the next regularly scheduled ALRC meeting (which is this upcoming meeting).




