I am very grateful that a proposal has been brought before the Finance Committee asking that the hours at the Monroe Street Library be restored to five days a week in 2022. That was the MPL Board's stated goal when it reduced Monroe Street's hours to three days a week for 2021, and I'm hopeful that you will be able to find the \$70,000 necessary to make this happen.

I've been chair of the Monroe Street Library League for over 35 years, and of the Monroe Street Merchants Association for some 45 years. In my mind the two organizations share the same goals: creating a walkable urban neighborhood with a high quality of life for children, adults and seniors. Having access to a public library helps make the Monroe Street area livable, and contributes to making our mix of small, locally owned businesses viable.

The Monroe Street Library League is eager to support the branch, and our volunteers have continued to raise funds for materials used throughout the MPL system, as well as most of the programs and furnishings for our branch. We are unable, however, to host any programming with the library open so few hours a week. Supervising Librarian Ching Wong recent wrote: "I agree with Orange's statements of the limited opportunities for programming due the limited hours and future funding. If and when the library hours are restored, Monroe Street Library staff and I will look forward to your full support in funding any collection and programming endeavors."

I could go on at great length about the reasons why the Monroe Street Library should be open five days a week instead of just three, but I hope that my actions over the past 35 years speak to my passion for this branch and the importance of libraries in general. Please feel free to let me know if you would like to visit our library in order to see how well used it is, even when patrons are limited to just Tuesday, Friday or Saturday. Let's hope that in 2022 they will have access five days a week!

I've been a Monroe Street Library patron since the late 1970's and an active volunteer there for many years. I'm sending this message to express my strong support for restoring the library hours that, due to the pandemic, have been reduced..

The MPL board voted last year to restore our library to its full schedule as soon as possible. Alder Evers' amendment to the city budget to expand the days of operation is consistent with this goal.

Monroe Street Library is the only library in the Madison system with just three days of service.

The Library Board and staff have received numerous comments from library visitors who support expanded service hours.

Programming for children and adults, which is entirely funded by the Monroe Street Library League, is not feasible with the branch open only three days per week.

A recent week-long survey showed that, despite its small size, Monroe Street Library received more visits per day than Goodman South Madison, Hawthorne or Lakeview. Also, more library materials were checked out per month than Goodman South Madison despite being open less than half the hours in May, June and July.

Because the neighborhood is so walkable, some users without cars or easy bus service are able to walk to the library on their own. The result: fewer vehicles on the road.

The City of Madison owns this library building and already pays utilities and maintenance so these expenses will not be part of the requested funding.

Our Monroe Street Library is truly a community gem. Please restore the hours that have been taken away .

As a longtime resident of Madison, I am writing this letter out of concern for the current proposed police budget. It seems counterintuitive to cut funding when the city is encouraging economic growth. The number of police officers on the street and behind the scene is very important to having a safe city.

Policing efforts include more than the big headline stories; every day policing efforts are very important to Madison residents. I want a full complement of officers to deal with incidents like sexual assault, carjacking's, home invasions, traffic accidents and speeding, and active shootings to name a few. Investigations in to past incidents are critical to right the ship and protect the victims. You may cite crime statistics in certain categories as going down, but the nature of many current crimes has become more violent for victims, so the statistics are misleading.

Admittedly, I am not a budget expert, but I know without adequate staffing in a growing population, Madison will become even less safe for residents. I know that budget issues are not simple and they should not be made without in depth study. I also do not want funds shifted from policing to support unproven programs.

As a resident of Madison, I am asking you not to cut more funding from the Madison Police Department. An analogy might be the first experience with illegal drugs does not often kill, but multiple experiences can be deadly. Shaving a budget can lead to big problems down the road, as the saying goes. I can speak from experience on this as I spent 38 years in the classroom and budget cuts do not solve problems; they create future problems of quality students and personnel.

P.S. Please study the repercussions of using up the "rainy day" funding ahead of the real rainy day. As a taxpayer, this possibility really concerns me.

The Vilas Neighborhood Association urges you to adopt an amendment to the Mayor's proposed 2022 budget to fund increasing the hours of service at the Monroe Street Branch Library from 3 to 5 days a week, as recommended by the Madison Public Library Board, the Madison Public Library Foundation, and our Alder, Tag Evers.

The importance of the Monroe Street Branch to this neighborhood is evidenced by the exceptionally high volume of use it receives from area residents, many of whom walk to get there. Increasing the hours would improve access to the library's services and put our neighborhood branch on a more equal footing with the service provided in other parts of the City. The Monroe Street Branch is smaller than other libraries and would understandably still have fewer hours, but it would be significantly closer to providing full service than is possible with the current 3-day, Tuesday-Friday-Saturday configuration.

Madison Finance Committee,

I oppose the cuts to the Madison Police Department as detailed in the proposed adjustments to the 2022 Executive Operating Budget (Item #17 – October 25, 2021 Finance Committee Meeting agenda) . What the cuts will do is to turn the department from a pro-active to a reactive department. Current public complaints revolve around reactive departments. These cuts will only result in those self-fulfilling complaints. Also, the Madison Police Department is experiencing more and extended periods of priority calls. The City Council is still demanding the current service levels without the resources to meet them. This is leading to an untenable situation. How can this situation be resolved? I would offer these solutions. First, don't send officers to Madison schools when fights break out like the one at East High last Wednesday. That disturbance required ten patrol officers and one supervisor. Why not send officers? The Madison Metropolitan School District has stated it has a highly trained safety team that can handle any eventuality. Secondly, don't send officers to ensure an area is safe for the CARES Team. Why? The CARES Team staff are experts in de-escalation and should not need police help. In fact, the CARES team is in existence because it is said uniformed officers just escalate situational tensions. Thirdly, don't conduct traffic enforcement operations on streets like Whitney Way where Traffic Engineering has reduced the speed limit to 25 mile per hour. Why? Motorists will voluntarily abide by the new speed limits. However, in actual experience that does not happen. I live a few houses from Whitney Way, and you can hear the high-pitched whine of motorbikes regularly speeding down Whitney Way to get to the beltline. Fourth, don't send officers to noise complaints to prevent further issues. Why? Because fights and subsequent murders won't happen. But they do happen as evidenced by the young man who was killed at a party by Breeze Terrace in September.

Yes, there will be detrimental consequences for not properly funding the Madison Police Department. But the responsibility for those consequences resides not with the Madison Police Department but with the Madison Common Council and rightfully so.

I'm writing in support of the Mayor's proposed budget for 2022 and against the amendments proposed by Alders Furman and Figueroa Cole which would significantly decrease the budget for MPD.

As Madison continues to grow, there is a need for adequate policing services for the community. We lost a large number of officers in this past year (2021) so far, and the loss of funding would not provide for adequate recruitment to replace even the ones that have left the department. Our police officers have had a difficult year, with shifts that have been much too long due to already inadequate staffing, with continuing loss of staffing, and an associated loss of morale. Those officers who in the past have worked proactively to minimize crime are now needed on patrol, so our communities will have fewer supports to help solve neighborhood issues that can lead to increased crime. I am also concerned about Amendment 19, which would remove funds for a position that would help in the collection of data to improve the functioning of MPD.

Dear Finance Committee alders and Mayor,

To propose taking \$795,000 from MPD's budget at this tipping point in our city's safety is negligence.

We're going to welcome almost 5000 residents from the Town of Madison but then tell them they aren't getting any police services? And MPD will lose 3 additional officer positions in addition to the 8---at a time when MPD is struggling to meet critical daily hard staffing minimums and gun violence incidents and reckless driving are affecting residents' daily quality of life like never before.

Please talk to or take a ride-along with the officers who are covering all of these overtime shifts. I have. They are burned out and morale is at an all-time low. They can't guarantee to their families that they'll be home to attend family events or pick up their kids from daycare or get time off for the mental or physical breaks they need. That's why so many of them are quitting or retiring. When they leave, all of their training (that we paid for!) and experience goes out the door with them.

And as a taxpayer I also don't appreciate paying for 1.5 cops and only getting 1 which is what happens every time an officer is called in early or is asked to stay late---all of us pay for their entire 12-hour shift, not just the 4 hours of overtime they put in.

Finally, while I (as well as the many police officers I've spoken to) hope the CARES program is a big success, it does not and will not ever replace the need for police officers to respond to most calls for service. And the program will not be able to relieve MPD of the most time and labor intensive calls---those involving weapons and those involving mental health detentions (because by state statute only a law enforcement officer can take someone into protective custody).

MPD responds to 400 to 500 calls PER DAY on average (pre-COVID that number was starting to hit the 600s). The CARES unit answered 37 calls in its first 5 weeks. Again, I wish them all the success in the world so they can help hurting people in our community. But during that 5 weeks, MPD responded to approximately 12,205 calls for service.

Even if this \$795,000 grab from MPD's budget is able to create 7 or 8 more CARES teams, they will only be able to respond to 400 to 500 calls PER MONTH. That's what MPD responds to in ONE DAY. And CARES will not be picking up bullet casings and interviewing families of victims lost to gun violence. Nor will they be arresting car thieves, domestic abusers or issuing tickets to reckless drivers on East Washington Avenue.

The CARES program is not a substitute for MPD officers and it should not be funded from MPD's budget.

Please vote NO on amendments 17, 18 and 19.

Dear Mayor Conway and Council Members:

I am writing today to voice my opposition to the proposed \$790,000 in budget cuts to the MPD & which includes cutting the needed 8 additional police officers to patrol the Town of Madison population by the MPD of 8,000 + by City Council members. We need these 8 additional police officers for the Town of Madison's merger with the City of Madison.

I do not approve of any funding being removed from our already-understaffed police department---especially at a time when violent crime and reckless driving on our streets is increasing.

MPD is seeing the highest number of resignations in 10 years and as of September 30th, resignations and retirements are 2 short of hitting the all-time record. So far this year 42 officers have left MPD. MPD is having trouble staffing shifts daily. Officers are staying over an extra 4 hours or are coming in early and working overtime to fill those shifts but it's become too burdensome. Officer morale is at its lowest point ever and many more officers are poised to leave for careers that won't make them work overtime every day or every other day. As a nurse, I understand how stressful and dangerous working short-staffed, especially on such a regular basis, is. Council members proposed cuts, reducing the police budget by \$795,000 which will impact the size of MPD's next year's recruit academy by 11 officers to replace officers lost to attrition and those 11 officers don't even begin to fill the gap.

More budget cuts will only increase attrition, and potentially mistakes, as I have seen in the hospital with increased hours, fatigue, and stress. In addition, when there aren't enough officers available for the city, the city goes into priority-only call status and officers are only dispatched to serious calls involving weapons, life in danger, or a traffic accident with injuries. All other calls are triaged until more officers become available again. When you call 911 or non-emergency you may be told by a dispatcher that your call is not urgent and therefore will have to be stacked in a queue. That is not the kind of service I expect from my city.

In addition, an amendment denies Police Chief Barnes his civilian position he requested that would "improve data collection and analysis supporting data-informed decision-making, violence reduction, and crime prevention." He considered this position the key to his success in doing more with fewer resources. His expertise is in data-driven police policy reform and innovation. This cut seems counterproductive.

While I support innovation in crime reduction, restorative justice, and police training, we need a fully staffed, well-trained police force in the meantime.

And with shooting and carjacking incidents at the gas station nearest to my house, I now only get gas during the daytime, and I feel apprehensive any time I go there.

This increase in violent crime incidents in my neighborhood is having a direct impact on my quality of life. A few weeks ago the occupants of two vehicles were shooting at each other on a street in my neighborhood. One of the stray bullets entered a home and struck a mattress. It landed only 12 inches away from someone who was sleeping in that bed. It's a miracle they weren't injured or killed.

We need MORE police officers that can have a presence and help solve crimes in our neighborhoods, not fewer.

We need these 8 additional police officers for the Town of Madison's merger with the City of Madison.

I do not approve of any funding being removed from our already-understaffed police department---especially at a time when violent crime and reckless driving on our streets is increasing. Mayor Conway did not propose these cuts, Council members did, reducing the police budget by \$795,000 which will impact the size of MPD's next year's recruit academy by 11 officers. The recruit academy is what is used each year to replace officers lost to attrition and 11 officers doesn't even begin to fill the gap.

MPD is seeing the highest number of resignations in 10 years and as of September 30th, resignations and retirements are 2 shy of hitting the all-time record. So far this year (as of 9-30-21) 42 officers have left MPD. MPD is having trouble staffing shifts daily. Officers are staying over an extra 4 hours or are coming in early and working overtime to fill those shifts but it's become too burdensome. Officer morale is at its lowest point ever and many more officers are poised to leave for careers that won't make them work overtime every day or every other day. As a nurse, I understand how stressful and dangerous working short-staffed, especially on such a regular basis, is. I strongly oppose the amount of money in the 2022 Executive Operational Budget that is going to the police department. Over \$84 million going towards the police (\$2 million more than 2021) is excessive, dangerous, harmful, and wasteful. It is well documented that funneling more funding into police departments, as well as allowing these departments to operate without impunity, does nothing to reduce crime. Police cause immense harm to Black and Brown communities, and we cannot police our way out of that reality. It is well documented that defunding the police and refunding community/social services offers much more promising outcomes for the health, safety, and livelihoods of everyone in our communities, especially Black people, Indigenous people, and people of color.

To the City of Madison Finance Committee:

I am aware that the Finance Committee is considering the Operating Budget for the Madison Police Department. This has been a year of increased scrutiny for police departments across the nation, and the Madison Police Department is no different. As an African American citizen who grew up in a large city with an aggressive police department that was often under the investigation of the US Justice Department, I am aware of the potential for the abuse of power that can occur within a police department. I am also aware of the increased concern of citizens of color for what has transpired over the last year with police across the country and within the state and I agree with the efforts to reallocate some of the city's resources designated for the police.

The city has already experienced some aspects of reallocation with the decision of the Madison Metropolitan School District to remove uniformed officers from its high schools. However, the proposed budget seems to be punishing the new police chief for the work of his predecessors. Madison regularly talks about not being able to attract a diverse, highly qualified work force. Well, it apparently convinced Chief Shon Barnes to take the job but one of your first actions seems to be tying his hands by slashing his budget. I strongly recommend that for his first budget, you allow the Chief to prove that his administration of the police department will represent a new approach to policing in this city.

The recent rash of car thefts, car jackings, home burglaries, and drive by shootings indicate our need for more preventative and community policing and is unlikely to be abated by slashing the police budget. I encourage you not to slash this budget in the first full year of Chief Barnes' tenure. This is an opportunity for Madison to demonstrate its true commitment to support of new leadership.

Dear Finance Committee Members,

On behalf of Blacks for Political and Social Action of Dane County, Inc., we write not to oppose any particular action or amendment on your agenda. Rather, we write to support Chief Barnes and ask that you give him the tools he needs to do his job.

In the hiring of the new Police Chief, we asked that they be allowed to assess the police department's needs (specifically, training) in order to provide safety, while not over-policing and enforcing Black and Brown neighborhoods in Madison.

We are encouraged to hear Chief Barnes acknowledge that racism plays a central role in not only the disparities that exist in the criminal justice system, but also in the enforcement of laws. We are also encouraged to see him in the community making authentic connections to marginalized populations.

We understand that there are three amendments you will consider tonight. Specifically:

- > Amendment 17: which reduces funding for the pre-service academy by \$164,000. This reduction would adversely affect the pre-service academy of 3 recruits.
- > Amendment 18: which reduces funding for the pre-service academy by \$510,000. This reduction adversely affects 8 pre-service academy recruits.
- > Amendment 19: reduces the funding for the Police Innovation, data, and Reform Director in the amount of \$121,000. This would adversely affect the Chief's programmatic thrust.

These kinds of cuts would place this Chief in an untenable situation. What is more, you would be treating this Chief differently than his predecessor.

While we do not support or oppose any specific legislation. We do support, however, Chief Barnes and his proposed budget.
