SUBSTITUTE - Creating Sections 38.03(7) and 38.05(3)(I) and renumbering current Section 38.05(3)(I) to (m) of the Madison General Ordinances to create a provisional retail liquor license.

Mr. Plant told committee members that is important that they not let the fact that an applicant has a provisional license weigh in on their decision to grant or deny a license.

Ms. Rearick mentioned that provisional licenses may complicate things if a density plan is in place.

Mr. McNamara said banks may require a license for financing purposes.

Attorney Zilavy told the committee that license holders could obtain a provisional license if they failed to file a timely renewal application. Captain Lengfeld suggested that a standard be established to prohibit the use of provisional licenses to avoid the renewal process.

Attorney Zilavy said that the City of Milwaukee will not issue a provisional license until their license committee rules on an original application. By limiting circumstances like the City of Milwaukee, and applicant could get a provisional license the morning after an Alcohol License Review Committee meeting.

Attorney Zilavy will draft a substitute ordinance that would limit provisional licenses to applications that the ALRC has Recommended to Council to Grant, and to emergency circumstances for existing businesses.

Madison has a quota of 399 Class B Combination Liquor & Beer licenses under state law. 56 of 74 Reserve licenses have been granted. 296 of 325 Grandfathered licenses have been granted. Taking into consideration the licenses recommended to Council to Grant at tonight's meeting, 47 Class B Combination licenses are currently available in the City of Madison.
