**From an email:**

"Following Chief Price and Captain Winter's call for emergency services to respond, Police Officers Ken Mulry and Michaela Rust arrived at Alder Harrington McKinney's residence at the same time as Medic 7. Fire breached the door to gain entry. Alder Harrington McKinney was immediately located by medics and police. Medics began assessing and treating Alder Harrington McKinney while officers cleared areas for the medics to work and ended the zoom call to further protect the Alder's privacy. Medics transported the Alder to the hospital while officers checked the house to ensure this was

purely a medical issue, shut off lights, and secured the house before leaving.

I would request Officers Mulry and Rust, along with the Medics from Station 7, be recognized at the ceremony. I was unable to determine the Medics assigned to the rig on that date.”
