AMENDING THE PUBLIC HEALTH BUDGET TO RECEIVE A GRANT FROM SUSAN G. KOMEN FOR THE CURE FOR THE TREATMENT ACCESS FUND

Since 2000, Susan G. Komen for the Cure has funded a Treatment Access Fund that is administered through the Well Woman program of Public Health. The fund provides breast cancer screening, diagnosis and treatment services for uninsured women in Dane County who do not qualify for any financial assistance program and do not have any form of health coverage. An eligible woman may submit her medical bills for breast related services. The program has negotiated with most health care systems in Dane County to accept a 50 percent payment on these bills. Based on available funds, breast related medical expenses, for eligible women, are paid directly to the healthcare provider. Since 2000, the Treatment Access Fund has assisted approximately 130 women and paid more than \$75,000 toward medical bills.

In 2007, 625 women were enrolled and screened through Well Woman in Dane County and twelve women were diagnosed with breast cancer with funding provided for their screening and diagnosis. Ten of these women were then enrolled in the state's Wisconsin Well Woman Medicaid to cover the cost of treatment.

Public Health—Madison and Dane County has received a grant for \$127,880 from Susan G. Komen for the Cure with the majority of these funds designated for screening and diagnosis of breast cancer. The Board of Health for Madison and Dane County has accepted the grant, but a budget amendment must be approved by Common Council and the Board of Supervisors to allocate these funds.

Policy Analysis Statement:

Brief Description of Proposal -

Public Health—Madison and Dane County has received a grant for \$127,880 from Susan G. Komen for the Cure with the majority of these funds designated for screening and diagnosis of breast cancer. The Board of Health for Madison and Dane County has accepted the grant, but a budget amendment must be approved by Common Council and the Board of Supervisors to allocate these funds.

Current Policy or Practice -

Since 2000, Susan G. Komen for the Cure has funded a Treatment Access Fund that is administered through the Well Woman program of Public Health. The fund provides breast cancer screening, diagnosis and treatment services for uninsured women in Dane County who do not qualify for any financial assistance program and do not have any form of health coverage.

Impact of Adopting Proposal -

In 2007, 625 women were enrolled and screened through Well Woman in Dane County and twelve women were diagnosed with breast cancer with funding provided for their screening and diagnosis. Ten of these women were then enrolled in the state's Wisconsin Well Woman Medicaid to cover the cost of treatment. This funding will enable the Treatment Access Fund to expand to work with more women.
