Plan to handle control and clearance of the parking lot during hours of operation and at closing time:

Except for 4-5 parking spots, most patron park on the street. We plan to install "respect our neighbor, keep your voices down" signs at each exit. Door personnel will frequently sweep the immediate entrance areas reminding patrons to not linger.

How will the entrance line be managed and controlled: _____

Lines never tend to exceed more than 3-4 people at any entrance. Because the bar is open at 11:00am there is never a rush to enter for shows.

Plan for unruly patrons, intoxicated patrons, and physical disturbances: _____

Unruly patrons will not be served and asked to leave. Intoxicated patrons will not be served, asked to leave and offered a taxi. In the event of a physical disturbance, by-standards will be shepherded away from the altercation and law enforcement will be called.

Underage drinking and fake ID plan: _____

The underage person attempting to purchase alcoholic beverages will be asked to leave and law enforcement will be notified of the attempt to purchase alcohol.

Plan to control and supervise patrons under twenty-one (21) years of age: _____

IDs of all patrons appearing to be below the age of 30 will be checked carefully. Alcohol will not be served to under age individuals.

How will orderly appearance and operation of the premises be maintained in regard to litter and noise:

As part of routine closing and opening procedures for the bar, staff will police the property, picking up all refuse. As indicated above, door personnel will make frequent sweeps of the areas near the entrances to the bar to ensure crowds do not gather/loiter.
