Dear Members of the Commission:

The YMCA has a new image. All of the locations are getting new signs, including this one on Medical Circle. Because of the zoning of this property, the new signs need to be approved by the UDC. Please accept this letter as our request for review along with the application, fee and drawings herewith.

Please see the photo showing the existing signs at this location. The only sign that is proposed to remain is the changeable copy board. Now, please see the drawing #53900, sheet 2 showing the new proposed signs for this elevation and the attached elevation. We understand that we need an 'exception' due to the height of the proposed signs – over 10' from the ground. We are asking that the existing logo be replaced with the new logo in the same place.

One the opposite wall, there used to be the old style letters that have already been removed. See attached photo. Again we are asking for the new signs to be replaced where the old signs were.

Please see sheet #1 showing the replacement letters and logo being proposed. Again, the new signs will go where the existing signs are.

We look forward to presenting this to you in person at the next meeting.
