# **Body**

WHEREAS, poetry promotes dialogue and understanding between generations; and

WHEREAS, poetry promotes civic responsibility, civic engagement, empathy, understanding, and mutual connection; and

WHEREAS, on December 13, 2021, the Madison Common Council passed Resolution No. 68286, RES-21-00343, establishing a Youth Poet Laureate Program; and

WHEREAS, on May 13, 2022 the Madison Common Council passed Resolution No. 71285, RES-22-00343 amending the Youth Poet Laureate Resolution so that the Youth Poet Laureate serves a one-year term in alignment with the National Youth Poet Laureate Program; and

WHEREAS, on the Madison Common Council passed Resolution No.72241, RES-22-00491 appointing Madeleine Bohn the City's first Youth Poet Laureate; and

WHEREAS, on April 6, 2023 the Madison Arts Commission issued a call for the Madison Youth Poet Laureate; and

WHEREAS, by the deadline of May 5, 2023 (number TBD) youth had submitted applications for the position; and

WHEREAS, on May 9, 2023 the Madison Arts Commission met to vet (number TBD) of applications; and

WHEREAS, after careful consideration the Madison Arts Commission recommend (Name TBD) to serve as the next Madison Youth Poet Laureate and (Name TBD) as first runner up, and (Name TBD) second runner up.

NOW, THEREFORE, BE IT RESOLVED, that the City of Madison names (Name TBD) to serve as Madison's next Youth Poet Laureate, with (Name TBD) first runner up, and (Name TBD) as second runner up; and
