Good Morning Ms. Rhyne

I wanted to give you a quick update on your AWS request. We have completed the standard Engineering warrant analysis, unfortunately the intersection did not meet these criteria. This is the engineer's study findings and not the final decision. What I wanted to do with this email is give you some lead time cause at one point you mentioned you may want to circulate a petition. Process wise---an option you have is to: ask me to place the item on the City's Ped/Bike/MV Commission for review of the intersection and a review of the Engineering study, you can request that a Stop sign be installed contrary to the engineering findings—essentially it is an appeal of the Traffic Engineer's recommendation. A petition is not necessary for you to have Ped/Bike/MV review this--that is your decision, I just wanted to give you the time if you wanted to circulate one.
