
Application for Change of Licensed Premise

Event Description:

Beer/Distiller Festival -- Outside of Karben4 Brewing underneath 30x60ft tent on September 7th, 2013.

This will be an all Madison area event – we plan to presell tickets, and we're only making 200 available in an effort to keep it small, intimate and controlled in year 1. We have invited 11 local breweries and distilleries to participate. Each company will occupy a 6 ft. table in which they will offer guests samples of their respective products – similar to many other local beer, wine, and distiller festivals around Madison. Tipsy Cow will be onsite providing inexpensive, festival appropriate food to the attending patrons. We have also commissioned a 6 piece bluegrass band to provide guests additional entertainment.
