Improvements include the construction City standard street, alley, sidewalk, and utility improvements to serve The Crest At Eagle Trace subdivision. Improvements to existing Schewe Road and White Fox Lane are required to provide ingress / egress to the subdivision. As a

Contract 9630 and the associated plans are for the construction of the public improvements required to serve the redevelopment of existing property at 413-417 W Mifflin Street and 416-446 W Washington Avenue by CRG Acquisition, LLC. Public improvements required for the redevelopment include sidewalk, terrace, curb and gutter, pavement, and storm sewer improvements on W Washington Avenue and W Mifflin Street. The developer will also construct private utility service laterals for the redevelopment. Abandoned driveways are to be closed with new curb and gutter and a new private drive apron to provide access to the redevelopment will be constructed on W Mifflin Street. The Developer is to coordinate with City Traffic Engineering and provide temporary streetlighting as needed to facilitate the construction of the redevelopment and protect existing City fiber and conduit facilities within the project area. Contract 9639 and the associated plans are for the construction of the public improvements required to serve the private development at 6702 Mader Drive by MAD Grove Two LLC. Public improvements required for the development include a new bus pullout on Maple Grove Drive and sidewalk, terrace, curb and gutter, and street pavement. The developer will also need to resolve conflicts between existing public street lighting and City owned conduit or fiber facilities that may be in conflict with any other public or private improvements. This will likely result in the protection or relocation of existing public street lighting, conduit, or fiber as required by City Traffic Engineering or City IT. Private utility services are to be constructed to serve the development. Any public street terrace tree protection, removals, and plantings are to be completed per approvals from City Forestry.

The Developer, Kelly Station, LLC, has been conditionally approved for a one-lot certified survey map (CSM), the demolition of a commercial building, a mixed-use building, and three residential buildings, and the construction a five-story mixed-use building at 2430-2450 East Washington Avenue and 10-16 North Seventh Street. Upon recorded of the CSM, the new address shall be 2430 E Washington Avenue. With the Developer Agreement, the Developer shall be responsible for a Public Sidewalk Easement for and the construction of a minimum five (5)-foot wide sidewalk, eight (8)-foot terrace, and additional one (1) foot for maintenance, where applicable, along the N 7th Street frontage, and a Public Sidewalk Easement for and the construction of a minimum six (6)-foot wide sidewalk, eight (8)-foot terrace, and additional one (1) foot for maintenance, where applicable, along the E Washington Avenue frontage. The City Forester has approved the removal of an 11" Crabapple tree on E Washington Avenue and a 23" Elm tree on N 7th Street. The Developer shall be responsible for planting a full stock of terrace trees adjacent to the project as directed by the City Forester. The Developer shall construct approximately 150 feet of new 12" public storm sewer and 2 public storm manholes on N 7th Street to accommodate the development. A private storm sewer lateral shall connect into a public storm inlet on E Washington Avenue. Private water and sanitary sewer laterals shall connect into public utilities on N 7th Street. The Developer shall be responsible for the construction of a new public sanitary manhole at the lateral connection into the public main. The Developer shall also be responsible for traffic control and all restoration in the public right-of-way.

City Traffic Engineering is requiring the installation of wider public sidewalk on University Avenue adjacent to Lot 3. The developer shall coordinate the design of the proposed sidewalk to protect existing City owned pedestrian crossing and fiber facilities. In the event that the final sidewalk cannot accommodate the current location of the existing pedestrian crossing or fiber facilities the developer shall relocate said facilities as necessary per plans approved by City Traffic Engineering and the City Engineer. This project will construct a new off road bike optimized singletrack trail at Country Grove Park. The proposed trail will consist of a loop approximately 1.25 miles long constructed of natural materials. The trail alignment runs in Country Grove Park and the adjacent greenways. The trail will be constructed by a professional trail builder using "lift and tilt" construction techniques to create a sustainable surface. The trail tread will be capped with a chip seal, all weather, surface and natural stone and wood features installed. The total estimated cost of the project is \$330,000

This water pipeline rehabilitation project will use a lining technology known as structural cured-in-place pipe (CIPP), a process where a woven fabric tube is saturated with a liquid epoxy resin, pulled through the inside of the deteriorated pipe, and then inflated and cured with hot water or steam to form a new plastic pipe inside the old pipe. The rehabilitated pipes have full structural strength (more than simply a coating or lining inside the old pipe) and are expected to last at least 50 years before additional maintenance needs to be considered. This will be Madison Water Utility's tenth year doing water main rehabilitation contracts in this manner. We have been working with the DNR through these years to develop, evaluate and refine successful specifications for this technology. The total estimated cost of the project is \$1,115,000.
