9. 03451 5817-5818 Gemini Drive - Grandview Commons - PUD(SIP), Twenty-Three Unit Condominium Project. 3rd Ald. Dist.

The motion required that the treatment of driveway and access aisles was not approved to allow the applicant to meet with the Fire Department to provide permeable paving to allow for more on-site infiltration, as well as consideration for a more durable base alternative on all building elevations within eight inches of ground level utilizing EIFS with a thicker substrate insulation board and heavyweight mesh under the base/finish coats above the base treatment.
