Estimates for Pre-School Children In Early Childhood Programs Dane County

These estimates were done for the United Way Born Learning delegation to address the question of how many children in Dane County age 2 through 5 were in some type of program.

The data chart includes data from regulated child care programs from the 4C March-April 2014 Survey. The return rate from the survey was 95% for group centers and 94% for part day pre-schools (including Head Start). 91% of the licensed programs solely serving school age children along with all of the data for MSCR programs in elementary schools. 2013 data or other sources were used to estimate attendance in non-responding programs.

The response rate for Family Child Care was 87% for licensed, 74% for provisionally and fully certified providers. Averages were used for non-responding family child care homes still in operation in September 2014

I added to it public school enrollment for children served on site in public school owned buildings for pre-k, 4k, and Kindergarten and 4K, Pre-k and kindergarten children in programs in private schools that are not regulated by state licensing (since that data is already in the 4C survey.) The school data is from the DPI annual school survey (i.e. PEM and NEM reports) taken in fall 2013 for the 2013-2014 school year.

There was no way to weed out duplicate enrollments – i.e. a child who might be in a public school kindergarten and a private child care though the way we code school age programs does reduce the overlap somewhat.

At this point the chart does not include children age 2 and 3 in birth to 3 nor children in other visitation programs.

Another issue is school district and zip code boundaries. Private schools and child care programs were coded by the zip code where they were located. I did not have time to do that for public schools outside of Madison – so you will see in the notes columns the occasional mention of data from one zip code included in another. As an example, Middleton schools include Cross Plains; Cottage Grove includes Monona; a section of Verona's zip now has a Madison School in it; etc.

The birth data is essentially the total births for the years that the children age 2-5 were born in.

Estimates for Low Income Pre-School Children In Early Childhood Programs Dane County

All data relates to preschool children age 2 to 5.

<u>Wisconsin Shares</u> is enrollment data from March 2014 for children who have part or all of their care paid for by the Wisconsin State Subsidy system. Data is from an extract file provided by the state. While the state data includes the home zip of the child, the data shown is based on the zip code of where the child is enrolled so it is consistent with the other available data.

<u>Other Government funded data</u> includes – head start enrollment for children <u>only</u> funded by Head Start for March 2014 (to avoid duplication with the children funded by Shares as Dane County serves a large number of children on state subsidy); as well as CCTAP data and City subsidy data also for March 2014. All of these are based on where the child is enrolled.

Public School enrollment data includes 4K, Kindergarten and pre-k programs. To obtain this data, I used the PEM reports from the DPI annual school survey taken in fall 2013 for the 2013-2014 school year and then multiplied the total data by the free and reduced lunch percentage at the school. No free and reduced lunch percentage exists for private schools so no estimate was able to be made of the number of low income children enrolled in those programs.

There was no way to weed out duplication but most of these programs are exclusive of each other. To receive city subsidy money you need to not be on Wisconsin Shares. Likewise most parents counted here as using Head Start or CCTAP are not also on Shares.

This chart is probably an undercount as it does not include older children in the birth to 3 program or children who may be on a private scholarship.

School attendance borders and zip code border s may not coincide. In the case of public schools outside of Madison I did not have the resources to code each school by the zip code it was located in. Let me know if that is needed.

I also do not have an estimate of how many children in each zip are low income.
