
The Parcel Numbers for the territory to be annexed are 062/0608-043-8002-0 and 062/0608-043-8330-0.

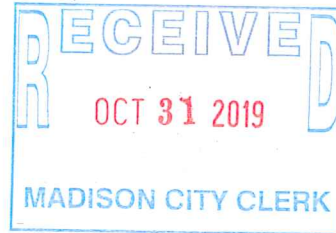

**EXHIBIT A**

LEGAL DESCRIPTION OF TERRITORY TO BE ANNEXED TO THE CITY OF MADISON

The NE 1/4 of the SW 1/4 of Section 4, T6N R8E, Town of Verona, Dane County, Wisconsin, except that part within the right-of-way of Woods Road previously annexed to the City of Madison by Register of Deeds Document No. 3421152, all more particularly described as follows:

Commencing at the Center of said Section 4;

thence N87°44'31"W along the East-West Quarter-Line of said Section 4, 33.01 feet to the Westerly right-of-way line of Woods Road and the existing corporate boundary of the City of Madison, and the Point of Beginning of this description;

thence continuing N87°44'31"W along the East-West Quarter-Line of said Section 4, 1265.58 feet to the Northwest corner of the NE 1/4 of the SW 1/4 of said Section 4;

thence S 01°05'32"W along the West line of the NE 1/4 of the SW 1/4 of said Section 4, 1319.76 feet to the Southwest corner of the NE 1/4 of the SW 1/4 of said Section 4;

thence S87°46'39"E along the South line of the NE 1/4 of the SW 1/4 of said Section 4, 1271.47 feet to the to the Westerly right-of-way line of Woods Road and the existing corporate boundary of the City of Madison;

thence N00°50'08"E along said Westerly right-of-way line and existing corporate boundary of the City of Madison, 1319.11 feet to the Point of Beginning.

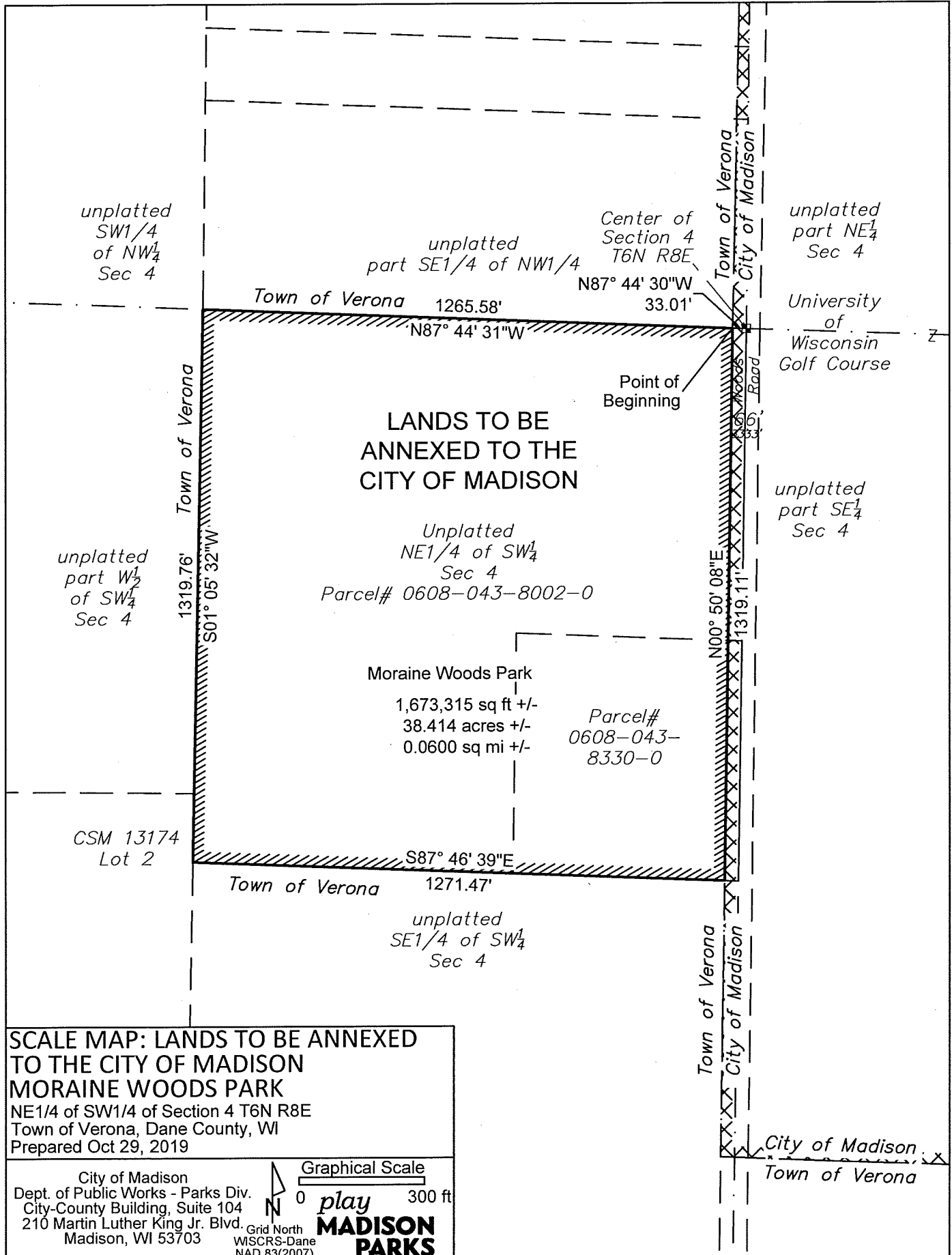
