Statement on why I wish to serve:

I wish to serve as alder to be a part of creating the safe, nurturing, healthy world that I want my children to grow up in, and that I, myself, want to inhabit. I hope to help shape what happens in the City of Madison regarding our schools and funding, our neighborhoods and communities, and our police and jails. I wish to focus efforts toward our resiliency in the face of climate change, our response to the needs of historically marginalized communities, and voting rights / ending gerrymandering / getting money out of politics. I hope to better understand the political realm, the needs of different communities, and what it takes to pass meaningful legislation. I hope to find a particular niche that I may fill where my interest, passion, and talent can be of best service to my community.

Statement on what I wish to accomplish:

I wish to bring forward and support the type of community-focused legislation and action that lets folks more easily "be good" and fosters resiliency within communities in response to climate change and other crises of today. Let's make it easier to compost. Let's make it easier to drive the speed limit. Let's remove barriers so that the kinds of behaviors that foster healthy, whole, and resilient communities happen by default. To me, that might include promoting community gardens and neighborhood composting, as well as edible landscape permits - all of which help to keep food and waste local. It could also mean flexibility in zoning regulations, infrastructure needs in response to flooding that keeps communities safe, and traffic and public transportation improvements. Additionally, support for wellness and mental health, facilitating conversations of healing within our communities, especially as folks have been dealing with the personal and social ramifications of the Covid pandemic for the last two years, and ending gerrymandering and voter suppression & getting money out of politics would be important areas of focus.

Statement on whether I plan to run for alderperson in the Spring 2023 election:

I do not currently plan to run for alderperson in the Spring 2023 election. While it is plausible that my time serving as alderperson would help me see the value in running for election, the time and financial constraints of working to be elected (compared with assuming a vacant seat) are significant compared to my available time and financial commitments, mostly due to my 3 kids, ages 1, 4, and 6.

Why I wish to Serve

I consider myself amongst one in million in India who accomplished more than they ever dreamt of. I attribute most of it to my good mentors, family support and the environment that I grew up in. The environment motivated me to challenge the status quo and break the walls & ceiling by empowering myself with education. Until the age of 25 I grew up in an apartment that was 150 Sq. ft. that received rationed water for two hours a day. Most of my neighborhood friends either didn't attend high school or didn't complete it. A lot of the friends that I grew up with had police records, sometimes because they did something wrong, but other times they happened to be at the wrong place at the wrong time. Yes, my parents struggled to put food on the table and pay for education for three boys, but as we got into our teens their biggest worry was to how to give us a better environment and save us from being "blacklisted" with law enforcement. During this struggle a lot of "angels", some I know about and some anonymous helped finance and refocus me on my goals.

Today, I am blessed to be in a very good position at a great company in the US, American Family Insurance. Throughout my life and career, I've benefitted from friends, colleagues, and community to get to where I am. By law of averages, I have 25% active life remaining, I have a strong desire to give back time to the betterment of the city that I now call Home. I want to contribute my time to make it the best place for our future generations. This nonpartisan position will provide me that platform to influence the decision we make for this city and its population.

What I wish to accomplish

I came to United States with only two suitcases of books and cloths, fast-forward 25 years, today I own a four-bedroom house and raising three daughters (our biggest wealth). I have been a resident of district 20 for more than ten years and I am a regular at Elver park. I want my young daughters to interact with kids and families that come to the park, yet I am sometimes reluctant to take my young daughters to Elver. I've heard from others, and I do notice that the environment is not suitable for young kids. But then I question if it is not good for my kids, how is good for others? Rather than being worried about my own kids, I want to create inclusive

environment so that every parent feels welcomed in and around the park and in the city. I know safety has been a pressing issue for Adler Albouras and there has been progress made on that front, I want to further that effort. I am not a policy maker yet, but I am confident that I will be able to engage the diverse constituents and appropriate departments to enable it. The Elver park use case is a personal goal for me to achieve, with or without being in the office. They say, “it takes a village to raise a child”, I want to make my small contribution to that.

Also, post Covid world has changed, we now live in a world that has increased the economic gap even more and as a result limited access to resources for our most vulnerable population. Eradicating poverty and unemployment are important to ensure we create a safe community. To address this, I will work for affordable housing by allocating resources for land banking, workforce development that provides good opportunities to our youth, and fund programs that support minority own business and BIPOC community. I will work towards creating programs that encourage teens to pursue and complete college, at minimum an associate degree that skills our youth to be financially sustainable. I have been in Information Technology for over 20 years, and I feel it is a great opportunity for women to get into this field. The flexibility it provides will enable women population to be in the workforce and provide financial independence to single moms. One other initiative close to my heart is renewable energy and environmental protection. I would work with the city’s planning body to incorporate sustainability efforts not only for creating green city, but also to view it as a source of generating employment for the city.

Finally, I will work towards finishing projects the has been initiated during Alder Albouras’ term.

While I am interested to serve, I am not ready to declare if I plan to run in the spring 2023 election. I want to take this opportunity to evaluate my own performance as an Alder for the district. I want to gain credible experience serving the residents through this interim period that will allow me to understand time commitment and do justice to the position. This will prepare me for opportunities in public service.

Statement of Intent to Serve

Madison has become my family's home for over a decade. Throughout the years our family has grown by three children (10yrs, 8yrs, 6yrs currently) and one small business. We have deep roots here between family, friends, businesses, and community.
