

Restorative Justice In the Community: Partnership with the different municipalities and DCDHS in collaboration with Briar Patch

Madison, Sun Prairie, Middleton, and Cross Plains

- Youth 12-16 yo who qualifies for a municipal ticket (non-traffic) is referred to RJ and have no record upon completion.
- Municipal Courts: Refer to RJ 12-17 yo to RJ process instead of fines or other punishment

Data

2019

641 mpd referrals

505 opted into RJ

83% of these referrals were youth of color

46 Municipal Court referrals

Recidivism

35 were referred again (5%)

95% were not referred again

2022 referrals have gone down to approximately 114





Progress and collaboration with MPD

Through our partnerships, collaboration and learning, we have developed practices which included eliminating discretion from the officer, so every youth who would have received a non-traffic municipal ticket has the option to participate in restorative justice as well as the creation of an internal system within MPD so the youth automatically receive a referral instead of holding a municipal ticket in abeyance. This means that youth who participate have no record of this interaction following them which has been an issue for young people who want to enroll in the military or have to navigate immigration systems, for example.

Progress and collaboration With City Council

In 2021 a Madison City Resolution was passed that integrates this process into how we officially respond to youth and makes it the first option and not an alternative to municipal court.

Endorsing all aspects of the restorative justice programs and encouraging MPD to take necessary steps to expand these programs.



Restorative justice is an anti-racist and decolonizing movement rooted in indigenous knowledge that recognizes the interconnectedness, value and intrinsic worth of all parts of creation. It aims to interrupt and dismantle the cycle of harm through the medicine of collective radical vulnerability and love.

Restorative Justice is abolitionist. It recognizes the need to heal, repair, and transform the historical and transgenerational harm from our society's practices and systems of retributive and unjust law embedded in white supremacist hetero-patriarchal and capitalist culture.
