Hi Tom and Yang,

I want to thank you both for everything you do. I cannot begin to imagine how much work went into the presentation you both (and your co-worker) shared at the February 9th meeting. I certainly hope that based on the proposed Phase 1 Budget (of \$500-\$700k) that the traffic calming project proposed for N Westfield Road to ensure the safety of those utilizing the Walnut Grove playgrounds, soccer fields and dog park will be approved in this first phase. We certainly don't want to let Annabel down!

I did want to get a few more details about the proposal to ensure I can accurately explain the request to the homeowners within our association.

Is the speed limit reduction proposal for the entire stretch of Westfield Road from Mineral Point to Old Sauk, or just from Southwick Circle to Farmington? (I'm hopeful it's the whole stretch, or beginning at Tree Lane at a minimum)

Speed humps (assuming directly across from the park only?)

Is the island addition at N Westfield and Farmington Way? This has been the greatest area of concern for residents

Crosswalks: can you confirm the addition of crosswalks not just at Colony Drive (as noted on the proposed project list) but also at the greatest area of concern for residents, N Westfield and Farmington? What is the plan for the Greenhaven and Southwick Circle crossings? Currently, there is zero yellow crosswalk signage and only minimal painted lines at N Westfield and Farmington, even though it's the busiest crossing.

Again, I very much appreciate everything you do and how helpful you've been in navigating this with our neighborhood. I want the Transportation Commission in which the approval process lies to understand that this is a city park with no parking lot and no public safety elements currently in place to ensure crossing safety for pedestrians. We have parents concerned about the safety of their children and we have elderly residents who feel unsafe crossing to access the park due to the speed of traffic.
