RE: Pellitteri Waste Systems plan for Kipp St.

It has come to our attention that Pellitteri Waste Systems is planning a new material recovery and transfer system on Kipp Street in Madison.

As citizens and nearby residents of the Lost Creek Neighborhood in Madison, this is of great concern to us and our neighbors. The person representing our neighborhood is <u>not</u> supporting the majority of residents that do not want a Pellitteri Waste Systems facility in our area. The representative stated at the August 17th public hearing that she heard few if any complaints regarding this proposed project, and that homeowners are at fault for not fighting the Treadesman Commerce Park when it was developed some years ago. Unfortunately, for a majority of the families living in our neighborhood now, we were not living in the Lost Creek Neighborhood at that point in time, nor were we informed until recent months that it was a waste system facility that was being built.

This facility is not just close to our neighborhood, but others as well, including the Veridian Secret Places subdivision, and in fact is only 45 short feet from those families residing on Marsh Road.

As the Plan Commission of our great city, I ask that you consider other solutions. Put the waste facility in the country away from neighborhoods of concerned citizens and families who want to stay here for years to come. Stop the demise of a neighborhood tarnished by additional truck traffic, noise, odor, as well as pest, well, and property value concerns from this facility.

Thank you for your attention to this important issue, and I hope that you consider the concerns of the citizens in this area.
