Hello,

This is a comment voicing my opposition to agenda item 11. I am a fourth generation Madisonian. I come to you with a concern not about whether or how we should make changes to our parks, but I come seeking assurances that any and all changes related to public lakefronts will keep valuable public land in the hands of Madisonians. My concern lies primarily with the possibility that vital parts of the public lakeshore park lands in question could be privatized, and agenda item 11 makes that more likely to happen by removing the requirement for voter approval before not just major construction, but also before changing the legal status of the lands in question.

The project proposal has not been clear about where funding will come from, and acknowledges the possibility of private funding. Meanwhile, there are two spots next to Monona Terrace that are essentially outlined for "possible future development". It doesn't take a wild imagination to see that these uncertainties contained within project proposal, alongside the proposed exemption on item 11, increase the chances that priceless public land is taken out of the public ownership. It also exposes this public lakefront to that risk in perpetuity. At best, the project is too undefined for us to know what's happening. At worst, the possibility of privatization has been kept in vague terms so as to avoid public opposition to the costly loss of public land.

There have been no assurances that public land will be kept in public ownership and not be sold to fund this project, and if it passes, agenda item 11 will remove the requirement to get public approval before privatization.

What assurances can we have from that vital public lakeshore park land will be preserved for Madisonians, not just for the duration of this specific project, but for generations to come. I seek no objections to the project's details and welcome improvements to our parklands. A move, however, that opens up pathways for privatization without public input and without assurances that public land stays public is a massive mistake and disrespect to Madisonians who value their lakefront.

Hi Alders-

I support putting the Madison Lakeway project to referendum. MGO 8.35 requires it.

When the rehabilitation and reuse of the historic Garver Feed mill in Olbrich Park was first proposed for an arts incubator in 2009, I supported the referendum required by MGO 8.35. But when the proposal fell apart and after the new selection process established Baum Revision as the preferred team, I proposed an exception, since the voters had overwhelmingly supported saving and reusing Garver to create a community benefit

At this point, the Madison Lakeway master plan is aspirational, and the costs are unknown. Yes, there has been a public process for visioning the Lake Monona waterfront and selection of a design team, but there has not been a public process to establish what is a feasible plan, to determine a realistic timeline for implementation, or what it will cost and who will pay for it.

At this point, I understand improvements to the causeway from the master plan are included in an engineering project for redoing John Nolen Dr that you budgeted for and have a federal match to help pay for. Is that the trigger for the exception? Then make that clear. Or are you including all of the ideas for Law Park and Olin Park in the Sasaki plan which include very expensive hardscape and are not vetted yet. I don't support that.

I could see doing more than one charter ordinance as plans unfold for the Lake Monona parkway. But for now we have the improvements to the causeway on the table with knowable costs. I hope voters would support it and wait for more information about all the other components of this plan for a future decisions in future referendums.

You have a responsibility to honor laws initiated by voters through the referendum process.
