Superintendent of Parks

Parks Superintendent Eric Knepp reported that the James Madison Park Master Plan is anticipated to be on the December Board of Park Commissioners agenda. The Urban Forestry Task Force continues to meet, and will likely release a recommendation next year. An Integrated Pest Management (IPM) Task Force is being formed, which will include Parks staff. Golf has had a difficult year and decisions about the future of the program are ongoing. The policy regarding dogs in parks is being reviewed. Knepp anticipates moving towards a less restrictive policy, with a recommendation next year. Operations and Forestry have been very busy with planting and flood damage repair. The pool and aquatics program had a successful season. Five Madison Parks staff members attended the National Recreation and Park Association Conference, including Public Information Officer Ann Shea, who spoke briefly about her experience.
