Memo: 2025 SEED Grants Funding Recommendation

Members of the Madison Food Policy Council, below are the recommendations for 2025 SEED Grants funding. Seven proposals were ultimately recommended for funding via a thorough deliberation process that included 3-member review teams to score and evaluate proposals and a group discussion on recommendation strategies. Please note that in total, 42 applications were submitted, requesting \$319,617.15 in total funding and that the SEED Grants funding authority for 2025 is \$50,000.

Review Team members wanted the scale of need they saw memorialized and so it should be noted that in 2025, the program saw a record-breaking number of applications and funding amount requests. And because of that, many worthy projects were unable to be funded - projects that had legitimate funding needs. These include pantry and emergency food systems supports, early childhood and senior education and engagement on gardening and growing food, pop-up meals and community feeding efforts, as well as efforts to provide nutrition education and well-balanced meals to children and families recovering from trauma, to name but a few. The 2025 SEED Grant application cycle clearly illustrates that there are very high – and growing – levels of community food systems needs within our city.
