Introduction

- 4. Proxie, LLC
- 5. Revelation, LLC
- 6. Urban Triage
- 7. Wisconsin Latino Chamber of Commerce

Summary of Evaluation Panel Activity

1. Panel members first conducted evaluations of proposals independently based on the pre-established criteria determined by the panel. Then, the panel met to discuss all qualitative and quantitative aspects of the proposals and overall ratings as a group. Please note that cost is typically factored into the scoring as 30% of the total. In this instance, the winning vendor would not be billing the City. The City would be paying the vendor with a set budget. Therefore, a technical question based on resource allocation was scored as part of the technical evaluation and not broken out as in most other RFPs.

Below is a summary of the scoring:

Based on the scoring, the panel wanted to have virtual interviews with the top four scoring vendors: Mad Rep, Madison Black Chamber of Commerce, Urban Triage, and Wisconsin Latino Chamber of Commerce.
