Dear Artists, Creative Workers, & Community Members,

The Madison Arts Commission (MAC) has been asked by the Common Council to review the report of the Overture Ad Hoc Committee and make a recommendation back to the Common Council (prior to 11/09/2010) about whether or not to accept the report.

As the citizen representatives charged with advising the Common Council about matters of arts and culture, MAC is calling a special meeting on Monday to discuss the report and determine if its contents reflect the concerns and interests of the community, particularly the creative community.

MAC extends a special invitation to artists, creative workers and community members to attend their meeting this coming MONDAY, NOVEMBER 8 at 6:00pm at the Goodman Neighborhood Center 149 Waubesa Street Madison, WI 53704. MAC is particularly interested in hearing from the artists, performers, producers, and consumers of arts and culture who utilize Overture. There will be a public comment period (3 mins each) for you to contribute relevant information that will aid the commissioners in their deliberations.
