Dear Landmarks Commission Members,

It is our intent to re-brand the station that is currently a Spirit Gas Station with the Heritage Amoco Brand.

After many years the Amoco brand which was the rebranding of the Standard Oil Brand, British Petroleum has decided to bring the brand back and use it at Strategic location in Wisconsin. This site was chosen as at one time it was originally an Amoco station before several rebranding over the years, thus we feel that this is a natural re-brand. The Amoco brand will contain the red, white and blue color scheme and will also be utilizing the Standard Oil Torch and Oval that historically was used for branding purposes.

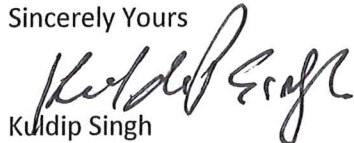
It is our intent, to decorate the outside of the station with the red, white, and blue color scheme that you can see with the accompanied photos and perspective drawings.

We are not requesting that the canopy fascia treatment to be illuminated and we are only requesting that just bullnose and/or colors of the bullnose to be on the canopy. We would prefer the 3-Dimensional look of the bullnose on the canopy fascia and we are also willing to narrow the free-standing ground sign and keep the sign at the maximum height of 12 feet, which the present sign presently is. With the torch and oval the proposed sign would be narrower and not be as intrusive as the existing sign. We would still like to have the electronic gas pricers, but the color would be red, the red gas pricer signs are part of the Heritage Amoco image. The request has been modified to meet City of Madison sign requirements.

It is also in our plan to continually to maintain the proper to maintain the standards that Heritage Amoco requires, so this maintenance will greatly enhance this location and also be a good reflection on this historic district.
