## CHANGE ORDER

## **System Supply and Maintenance Agreement**

This Change Order, made and entered into by Trapeze Software Group, Inc. ("Trapeze") and the City of Madison Metro Transit ("City" or "Metro Transit") shall become effective upon execution of the Mayor of the City of Madison.

## WITNESSETH

- 1. On February 10, 2016, the City and Trapeze entered into a System Supply and Maintenance Agreement setting for the terms and conditions for the provision of equipment, software, software licenses, and/or software maintenance services.
- 2. Exhibit C to the System Supply and Maintenance Agreement set maintenance prices for the years January 1, 2015 December 31, 2023 for Trapeze products used by Metro Transit.
- 3. Section 15 of the System Supply and Maintenance Agreement includes a process for changing any price, schedule or statement of work for services to be performed under the System Supply and Maintenance Agreement.
- 4. Pursuant to Section 15.1.1 of the System Supply and Maintenance Agreement, the City requested changes to the Agreement to establish maintenance pricing for Trapeze products used by Metro Transit from January 1, 2024 to December 31, 2024.
- 5. Pursuant to Section 15.1.2 of the System Supply and Maintenance Agreement, Trapeze provided the City with a detailed proposal including updated maintenance pricing from January 1, 2024 to December 31, 2024 for Trapeze products used by Metro Transit, attached hereto as Schedule C.
- 6. The parties now wish to enter into this Change Order in order to set new maintenance prices from January 1, 2024 to December 31, 2024 for Trapeze products used by Metro Transit as provided in attached Schedule C.
- 7. The Parties agree that pursuant to Section 15.1.4 of the System Supply and Maintenance Agreement that this Change Order shall be subject to the terms and conditions of the System Supply and Maintenance Agreement.

NOW, THEREFORE, in consideration of the following mutual covenants and conditions, including the above recitals, which are made part of this Change Order, the Parties hereto covenant and agree with each other as follows:

- 1. Attached Schedule C shall be added to Exhibit C of the System Supply and Maintenance Agreement entered into between the City and Trapeze on February 10, 2016.
- 2. This Change Order shall be subject to the terms and conditions of the System Supply and Maintenance Agreement entered into between the City and Trapeze.
