Madison Metro Sewerage District update on salt reduction studies and other MMSD water quality initiatives.

Kathy Lake, P.E., an Environmental Specialist with Madison Metropolitan Sewerage District (MMSD), made a presentation on MMSD's overall chloride reduction strategy. Included in the discussion was MMSD's overall findings of their salt reduction pilot study (water softeners) and roles that the COE could play in advancing the chloride reduction initiative.

Committee members discussed the identified areas of Road Salt Reduction and Softening Efficiency.

Road Salt includes training for salt applicators in the City (City contracts and employees), using WiSaltWise to shift expections and support Behavior Change Initiatives, which includes educating through existing networks (neighborhood associations and environmental groups).

Softening Efficiency includes updating and optimizing softening technology in City owned/managed buildings. Exploring requirements to have time clock softeners changed out at point of sale and implementing minimum efficiency standards for softeners.

COE will discuss these areas at a future meeting.

Ald. Wood spoke in general about the budget process and timeline. At February meeting, Ald. Wood will address timeline and process for the 2017 budget as the committee looks into supporting Road Salt reduction and Softening Efficiency initiatives.
