Nick Zavos was present for the discussion on this item. Challenges abound: substantial state budget deficit, a governor running for president. He noted that they will be watching for changes/possible cuts to:

Shared Revenue
Transit Aid
Payments for Municipal Services
Room Tax Control
Revenue Limits
Personal Property Tax

Mr. Zavos will keep alders updated as the legislative session proceeds.

Registration: Sue Pastor, Opposed/Spoke, Madison

Sue Pastor opposed moving all testimony after public hearings on the Council agenda. Impact of testimony may be lessened if not provided when the issue is taken up by the Council. Access to the Council through public testimony is part of the democratic process. She provided a handout from her classroom entitled, "Some Aspects and Assumptions of White Culture in the United States" (attached to legislative file) and suggested the Council look at the process through an equity lens.

Ald. Chris Schmidt noted that reorganizing the agenda hasn't worked but certain items appeared like they would go quickly, did not. He thought having all public hearing at the beginning of the meeting could be a solution.

Ald. Shiva Bidar-Sielaff thought that what was unpredictable was council behavior (i.e. debate), not the public's testimony. She suggested making it part of the Council leadership role to determine just before the Council meeting the reordering of the agenda.

Ald. Mark Clear noted that re-ordering the Council agenda doesn't get to the issue of the public waiting long periods of time to testify. He thought expanding the early public comment time period to allow anyone to speak, not just those with medical, transportation or day care issues. Allow the public to make their own choice; testify early or wait until the item is taken up by the Council.

Ald. Denise DeMarb moved to approve, seconded by Ald. Maurice Cheeks. Ald. John Strasser was present for discussion on the item. He spoke of his experience with Nextdoor.com and his frustration of not being available to access certain neighborhoods. He would like the city to be able to access the "City" feature available in Nextdoor.com (making it available to alders, police, streets, etc...).

The City Attorney had concerns with entering into a contract with Nextdoor.com. Representatives have not responded to requests for certain contract elements being included. It was agreed Nextdoor.com could be a benefit for the city but members wanted the issues outlined by the City Attorney to be addressed.

Ald. Mark Clear was more concerned with Nextdoor.com going out of business as a risk for the city after investments are made.

Ald. Shiva Bidar-Sielaff made a substitute motion to refer to the 2/3/15 Common Council Organizational Committee, seconded by Ald. Marsha Rummel and asked that the City Attorney's recommendations be included in the resolution. Motion was approved by voice vote/other.
