Dear Common Council Members:

We are writing regarding the upcoming appointment of the replacement for the District 13 alder seat. We live in the 13th District and believe that appointing a well-suited replacement that best represents this diverse district is of critical importance for both the short- and long-term well being of the district.

We believe that Zach Madden is clearly the top candidate for this position. Zach has significant knowledge of the district and has worked incredibly hard to understand the concerns and priorities of those who live in the 13th district. In addition to running a strong campaign for the seat during the last election, Zach has continued to actively engage with members of the district on important neighborhood issues since the election. His maintained commitment to the district demonstrates that he has the best interests of our neighborhoods at heart and is willing to work hard on our behalf.

Some council members have expressed legitimate reservations about appointing an alder who would then run as an incumbent in the next scheduled election. We certainly respect the desire of many of you to not provide what some might perceive as the unfair advantage of incumbency to someone who has not won an election. However, as residents of the district who will be directly affected by the council's choice of alder, we wish to express our strong preference that whoever is appointed by the council be someone who plans to run for reelection. We want our alder to be accountable to the district for his or her decisions and to have an incentive to solicit and be responsive to constituent feedback. An alder who only plans to fill the seat for a year has no such incentive and we believe that this outweighs any of the public policy concerns regarding an appointed incumbent running for reelection. In our view, Zach's clear articulation that he will run for reelection only further demonstrates his commitment to serving the best interests of our district.

If for some reason the council does not choose to appoint Zach, we strongly encourage you to appoint someone who has demonstrated that he or she will represent the interests of the district and build consensus among its residents. It is in this vein that we wish to express serious reservations regarding one of the applicants for the position: Ken Golden. While we have no personal relationship with Mr. Golden, we were very negatively impressed by his conduct in regard to the development on Knickerbocker St. and Monroe St. last year. During that process, Mr.. Golden evinced an almost hostile attitude to the people who he now wishes to represent on the Common Council. His actions and opinions demonstrated that he is completely out of touch with the district. As a result, appointing Mr. Golden would likely lead to significant discord in the district and undermine any chance that our district's interests will be effectively represented on the council.
