Call to Order / Roll Call

The meeting was called to order at 5:08 p.m.

Present: 4 - Gary A. Weber; Joanne Wagner; Chris Hendrickson and Fayth E. Kail

1. Approval of Minutes - June 17, 2014

A motion was made by Kail, seconded by Weber, to Approve the Minutes. The motion passed by voice vote/other.

2. Public Comment - None.

3. Disclosures and Recusals - None.

4. Update on Status of Robert Van Kampen's application to serve on the Parking Council for People with Disabilities.

Putnam said that committee appointments are going before the Mayor on Thursday, and will know more after the meeting.

5. Kail and Weber to provide status of contact with Joe Schraven, Madison City Channel, regarding PSA.

This item was referred to the next meeting.

6. Weber to provide update on status of Dis/Vet spaces at South Madison Branch Library.

Weber has not seen a change in the status of the spaces.

7. Putnam to provide update on status of concrete planters next to parking space reserved for persons with disabilities on 100 S. Pinckney St.

Kail said that two of the planters have been removed, and will check to see if the remaining planter is in an acceptable location.

8. Discuss reinstating the Disabled Parking Enforcement Assistance Council.

Wagner said that DPEAC members see things that PEO's do not see, and PEO's cannot enforce violations that they do not see. Weber said that he called for a violation, and that while he was talking to the motorist who had parked illegally, a Parking Enforcement Officer arrived and wrote a citation.

Hendrickson asked if there was any formal response to the PCFPWD letter that Wagner drafted to the Mayor's office and Police chief. There has not been a formal response.

Putnam noted that very few reports were written by DPEAC before it was disbanded. Wagner noted that when someone sees an infraction they can call 266-4275 or for signage issues on private property, contact George Hank in Building Inspection.

9. Discuss issue of snow being piled in Disabled stalls.

There was no discussion on this topic. This item will remain on future agendas.
