DISCUSSION ITEMS

1. <u>21889</u> DISCUSSION ITEM: Make illegal any airborne art or airborne performance art such as spray painting and air brushing.

The following licensed Mall/Concourse Arts & Crafts vendors spoke in opposition to allowing spray paint art to be performed near their designated Arts & Crafts sites: Chuck Tupa, Marcia Sparks and Jeanette Burda. Speaking in agreement with them was Rick Sparks.

Two petitions were submitted with a total of fifty-four signatures, in opposition to allowing spray paint performance art to be allowed within 200 feet of "licensed craft or food vendors."

Tupa also submitted a drawing he had done to illustrate the presence of toxins near performance spray paint areas.

At Verveer's request, Hansen had distributed copies of an email message from Mary Carbine (BID) expressing concerns about safety hazards related to spray paint artists and their not having to purchase licenses.

The following two spray paint performance artists spoke in opposition to making spray performance art illegal: Andy Watkins and Travis Knapp.

After discussion, Verveer asked Assistant City Attorney Lara Mainella to draft an amendment to ordinance 9.13 creating a new vendor category with appropriate guidelines.

 DISCUSSION ITEM: Allow one individual to purchase two separate types of Mall/Concourse licenses in some circumstances, such as both Food and Sidewalk Cafe, etc.

Hansen wished to have the ordinance updated to allow an individual to purchase two separate types of Mall/Concourse licenses, such as Food and Sidewalk Cafe. Mainella was to make suitable changes to the ordinance.

 DISCUSSION ITEM: Consider allowing Merchant Vendors to display seven days per week, as Sidewalk Cafes do.

Hansen said that merchant vendors had long been asking him why they were limited to four days per week when sidewalk cafes could be open every day. Mainella was asked to draft suitable language to make the change to seven days per week.

 DISCUSSION ITEM: Consider putting numerical cap on some types of street vending, such as Arts & Crafts and Mall/Concourse Food Carts; create waiting lists for additional applicants.

Hansen said that he felt that some categories of street vending had reached capacity and that maximum numbers should be established, with related waiting lists. It was suggested that he meet with Mainella to discuss this with regard to existing ordinance language.
