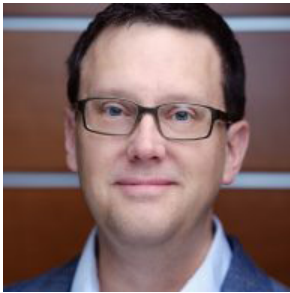




### **SHARON CORRIGAN**

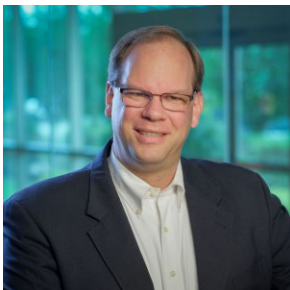
### **SKIP HARLESS**
