



## Notes on proposed changes to licensed premises

- Proposed changes only in effect on the following dates and times of the Madison Night Market:
  - o Thursday, May 11 2017 from 6pm 11pm
  - o Thursday June 8 2017 from 6pm 11pm
  - O Thursday July 13 2017 from 6pm 11pm
- Parking lot space provides approximately 4,800 usable square feet of space with requested capacity of 384 persons
  - o Parking lot area is approximately 60 wide by 120 feet deep (7,200 sq ft). Proposed usable area covers 60ft lot width times 80ft depth (4,800 sq ft), with a requested capacity of 384 persons, allowing 12.5 sq ft per person as some tables and chairs will be provided.
- Proposed space has existing steel fence surrounding the perimeter of the parking lot area and
  features a swinging gate that will be partially closed on one side to limit access and provide a
  checkpoint for staff to check IDs and wristband all attendees. Gate may be opened to allow
  additional exit space in case of an emergency.
- All attendees will enter and exit through a checkpoint at the base of the parking lot adjacent to Gilman Street.
  - o Staff will be on hand to check IDs, wristband all attendees and control capacity. Signs will be posted at exit "No Alcohol Beyond This Point" and Staff will direct attendees to dispose of any containers before exiting the designated area.
- The only alcohol to be served to attendees will be beer served from a temporary mobile trailer.
- Will cease sale of alcohol at 10pm to allow ample time for the space to be cleared prior to the 11pm closing time of the Madison Night Market.
- Additional decorative lighting will be installed and used during the event hours
