## County Budget

- County Executive released the budget 09/18/24. Health and Human Needs met on 9/27 and will meet also on 10/01, and 10/07 to discuss the budget and review any potential amendments.
- Changes that may impact housing and services
  - No COLA proposed for POS contracts
  - Increase of \$100,000 to the Beacon Day Resource Center to support staffing (To cover the loss of a major funding source).
  - Increase of \$5 million for the Dane County Affordable Housing Development Fund, bringing it to \$10 million.

### Contract updates

- Contract renewal process has started
- Farmer Workers Housing In beginning stages of research (no updates)
- Fair Chance Housing Provider selected (EXPO) and routing through legislation
- CDBG and HOME funding RFPs for 2025- Projects have been recommended for funding and are pending County Board approval.
- AHDF- The 2024 County Capital Budget includes \$15 million and applications under review. For a list of all housing developments visit: <a href="https://dcdhs.com/haa/hd">https://dcdhs.com/haa/hd</a>; A resolution is anticipated to be introduced on 10/10.

## Doubled Up Pilot

#### As of October 1, 2024:

- 42 families housed
  - Range of children in household: 1-5
  - 20 under 30% AMI
    - 4 zero income
  - 18 = 30%-50% AMI
  - 4 = 51%-80% AMI
  - Avg. rent assistance = \$7,787
  - 18 received funds to clear rental arrears due to housing barrier
  - 5 received funds to clear utility arrears due to housing barrier
- 8 households pending lease signings



### Hotels to Housing

#### 10/31/24 (Preliminary final data

- 291 HHs housed (14 HHs still housed 09/30) [341 HH enrolled with 85% placement rate]
- 26% of HHs housed were non-renewed (62% were rehoused)

<u>Housed exits</u> = 291 (highlighted estimates)

- 55% exited to housing: 24% EHV, MVP, S8 or other housing program + 31% paying on their own
- 30% not stay in apartment (62% using shelter, outreach, safe haven, or beacon services; 38% is unknown)
- 16% Other situation
  - 9% deceased or long term care, 5% relocated or domestic violence, 2% incarcerated (longer than 90 days)



# American Rescue Plan (ARP) funded programs wind down timeline

- Hotels to Housing Program ends 10/31/24.
- Outreach Services through Catalyst for Change Funding/contract ends 12/31/24
- Doubled-Up Housing Pilot Funding through 09/30/25 (per federal regulations)
- Eviction Defense and Diversion Program (EDDP) Funding currently through 12/31/24; Legislation routing to extend contract through 09/30/25.
- Isolation and Quarantine Center Hotel Program ended 04/30/23
- Dane CORE– Portal for new applications closed 05/31/23
- Emergency Rental Assistance Security deposit program ended 12/31/23
