





The West 1/2 of the Southeast 1/4 and part of the East 1/2 of the Southeast 1/4 of Section 24, Township 7 North, Range 10 East, in the Town of Blooming Grove, Dane County, Wisconsin, described as follows: commencing at the Northwest corner of said East 1/2 of the Southeast 1/4; thence East 75 rods; thence South 1 rod; thence West 10 rods; thence South 10 rods; thence East 10 rods; thence Southwest to a point on the South line of the Northeast 1/4 of the Southeast 1/4, 35 rods West of the Southeast corner thereof; thence South 27 1/2 rods; thence West 45 rods; thence North to the place of beginning.

Excepting from the above lands, land described as follows: Beginning at a point on the South line of the Northeast 1/4 of the Southeast 1/4 of said Section 24, which is 577.5 feet West of the Southeast corner thereof; thence North 19 degrees 51' East along the Easterly line of parcel of land described in Volume 497 page 410 as found in said Register's office, for a distance of 244.0 feet; thence North Westerly parallel to center line of highway located in the Southeast 1/4 of the Southeast 1/4 for a distance of 178.0 feet; thence South 19 degrees 51' West, 244.0 feet; thence Southeasterly 178.0 feet to the point of beginning.



Located in all Quarters of the Southeast Quarter of Section 24. Township 07 North, Range 10 East, City of Madison, Dane County, Wisconsin, more fully described as follows:

Commencing at the East Quarter Corner of said Southeast Quarter of Section 24; thence South 88 degrees 38 minutes 13 seconds West along the north line of said Southeast Quarter, 111.70 feet to a point of curvature and the Point of Beginning; thence 17.50 feet along a curve to the right, having a radius of 905.40 feet, a central angle of 88 degrees 53 minutes 34 seconds and a long chord that bears South 19 degrees 49 minutes 50 seconds East, 17.50 feet, to the point of tangency thereof; thence South 88 degrees 30 minutes 36 seconds West, 169.66 feet; thence South 19 degrees 52 minutes 50 seconds West, 263.71 feet; thence South 86 degrees 49 minutes 54 seconds East, 155.60 feet; thence South 20 degrees 33 minutes 43 seconds West, 888.57 feet; thence North 83 degrees 04 minutes 01 seconds West 178.00 feet; thence South 20 degrees 29 minutes 54 seconds West 244.00 feet; thence South 00 degrees 21 minutes 42 seconds West, 211.07 feet to the northerly right-of-way line of Femrite Drive; thence North 83 degrees 11 minutes 17 seconds West along said northerly right-of-way line, 1070.12 feet; thence North 02 degrees 11 minutes 58 seconds East, 220.97 feet; thence North 83 degrees 11 minutes 21 seconds West, 180.00 feet; thence South 02 degrees 12 minutes 18 seconds West, 220.96 feet to said northerly right-of-way line; thence North 83 degrees 11 minutes 17 seconds West along said northerly right-of-way line, 534.99 feet to a point of curvature; thence 138.72 feet along a curve to the left, having a radius of 1233.00 feet, a central angle of 83 degrees 33 minutes 15 seconds and a long chord that bears North 86 degrees 24 minutes 40 seconds West, 138.64 feet, to the point of tangency thereof; thence North 89 degrees 38 minutes 02 seconds West to the west line of said Southeast Quarter, 3.39 feet; thence North 00 degrees 24 minutes 21 seconds East along said west line, 1245.79 feet to the Center of said Section 24 and the north line of said Southeast Quarter; thence North 88 degrees 38 minutes 13 seconds East along said north line, 2579.75 feet to the Point of Beginning.
