APPROVAL TO CLOSE CENTRAL LIBRARY ON MARCH 8, 2016 FOR PRIVATE EVENT

A motion was made by Galanter, seconded by Markle, to Approve.

Greg Mickells began the discussion with an overview of the timeline of events leading to the request and the recommendation received from the Madison Police Department to close the building due to the high level of security needed. Mickells also distributed copies of WI State Statute 43.58. Liz Vanderwerff and Josie Larimer from the Center for Healthy Minds at UW-Madison explained the event is a reporting of researchers from UW Madison along with supporters and others who have collaborative relationships with the UW Center for Healthy Minds. They anticipate a crowd of 70-80 in attendance. The security concerns are due to the presence of the Dalai Lama at the event. Mickells reported only 6 MPL staff members would be allowed in the building and they would be subject to a security clearance including the collection of their social security numbers. It is expected that the streets surrounding the library will be closed and anyone entering the building would be subject to a TSA type screening. Mickells stated he did not want to put MPL staff or patrons at risk by keeping the library open if that level of security is needed.
