- What happens to the VOCs & PCEs that get filtered out of the water?

- PCE = tetrachloroethylene/perchloroethylene dry cleaning solvent / degreaser. (tetra/per= four) Not to be confused with TCE = trichloroethylene.
- What about households that would prefer to filter but can't afford filters?
- Does the panel drink filtered water or out of the tap? What about filtering at the wells?
- Will Well 8 be replaced or filtered? When?
- What would happen if VOC levels at Well 15 exceeded EPA standard levels before MWU was ready/ before project was completed?
