I write to you as a Madison resident, urging you to authorize emergency funding to allow the Office of the Independent Police Monitor to conduct a full investigation into the murder of Corey Ruiz by a Madison police officer on July 22.

Our community needs justice and accountability. This starts with a complete and independent investigation. The OIPM must be equipped with full-time investigators, a case management system and independent legal council. They currently have one part-time data analyst and an annual budget of \$400,000. Meanwhile, MPD has 584 staff and a budget of \$90 million. That disparity is a choice.

Corey was shot in middle of the street, 3 blocks from where I live. Friends of mine were at the intersection and witnessed his horrific death at the hands of MPD Officer Keil Peterson. Our neighborhood is still traumatized from an all too similar event 11 years ago, when MPD Officer Matt Kenny responded to a request for a wellness check by breaking into Tony Robinson's house and murdering him.

Choose to invest in justice and healing for our city. We cannot wait for the 2027 budget cycle to resolve this crisis. We need action now.

I have been a Madison resident for the last 8 years. I have made an intentional choice to stay in Madison for possibly the rest of my life. I am writing to demand emergency supplemental funding for the Office of the Independent Police Monitor. MPD receives \$90 million. The OIPM receives \$400,000.

That disparity is a choice. I am asking this committee to make a different one. This cannot wait until 2027.

In Madison, how many MPD-caused deaths will be enough for you to take real action to hold officers accountable?

July 2026 - Corey Ruiz is killed by Kiel Baitinger-Peterson (still employed)

March 2015 - Tony Robinson is killed by Matt Kenny (still employed and trains new officers today)

2012 - Paul Hennen killed by MPD (also on S Baldwin)

2006 - Victor Montero-Diaz killed by MPD (also on Willy St)

This is MPD's own de-escalation policy. Read it. Then ask what happened on the street where Corey Ruiz was killed. It says:

"If feasible, under the totality of the circumstances, officers should attempt to slow down or stabilize the situation so that more time, options, and resources are available for the best possible resolution."

It lists specific tactics officers are required to consider:

- Have only one officer communicate with the person at a time
- Request Mental Health Officers or Crisis Negotiation Team members if indicated
- Use distance and time, when feasible because more distance creates more time to consider less lethal options
- Use cover and concealment place environmental barriers between the person and officers
- Take steps to calm the person
- Actively listen to the person's concerns
- Explain the person's options
- Orient the person to reality
- Attempt to be truthful
- Gather additional information about the person

It goes on to say:

"Once the subject and scene have been stabilized, officers should work to resolve the situation using the least restrictive measures to secure the welfare of all those concerned, to connect individuals with mental illness or substance use concerns to needed services, and to divert them from the criminal justice system whenever possible."

It specifically says: "Strong consideration should be given for a medical evaluation, particularly when the source or reason for the behavior cannot be determined or if the source is suspected drug use or a mental health crisis."

It says MFD personnel should respond to the scene or the subject should be transported to an emergency room.

This is MPD policy. Written down. In their own documents.

Corey Ruiz was on a bicycle. He was chased. He was wrestled to the ground. He was shot three times.

We do not yet know everything that happened on that street. The investigation is ongoing. There are no body cameras to tell us what the officers saw or when they made each decision. But this community has a right to ask in public, on the record, and with an independent office backing the question whether every one of these steps was considered before a man lost his life.

That is not a hostile question. That is the question MPD's own policy demands be answerable. The Office of the Independent Police Monitor has the authority to investigate whether MPD's policies were followed. To examine officer decisions. To compare what happened against what the policy requires. To put findings on the public record.

That is why we are fighting to make sure the OIPM has independence, resources, and the authority to do this work without interference.

MPD wrote these policies. The community is entitled to know whether they were followed. Corey Ruiz deserves that answer. His family deserves that answer. This community deserves that answer. The OIPM must have the resources to conduct a full independent investigation — full-time investigators, a case management system, and independent legal counsel.

Dear Finance Committee Members and Alders,

I'm a Madison resident who lives a half mile from where Corey Ruiz was shot and killed by MPD. I'm writing today to urge the city to immediately provide funding and staffing for the OIPM to a level allowing it to properly and immediately investigate this shooting and other reports of potential police misconduct. Additionally, we must immediately fund and require the full time use of body-worn cameras for all officers.

If there are not sufficient available funds for this, then I suggest the police department have all funding for lethal weapons, ammo, and associated equipment immediately withdrawn, and require them to begin auctioning off such weapons in order to fund both the OIPM and body cameras. I say this not in jest, but to ask you to seriously consider this if you otherwise cannot fund these essential safeguards against police misconduct.

Guns (like many devices) are dangerous tools, and safe, responsible use of dangerous tools requires the proper safety equipment, training, and procedures. We'd never suggest to someone that they buy a motorcycle first, and only get the helmet, rider training, and insurance AFTER they can afford it... no, we'd insist that no one should be allowed to operate a motorcycle without FIRST obtaining training and safety equipment, and if they can't afford the latter, then they have no right to the former.

I firmly believe arming the police is a similar situation, just writ large... armed officers are a potential danger to everyone they come in contact with. To ensure that danger is mitigated, body-worn cameras, INDEPENDENT, well-funded investigation of misconduct, and maximal transparency around training and procedure are essential for the safety of the community the police are meant to protect. If we cannot afford the safeguards necessary to ensure responsible policing, especially when it comes to the use of deadly force, then we shouldn't be funding the ability to DEPLOY that deadly force.
