Authorizing the adoption of amendments to the "Regulations Governing Vending on the State Street Mall/Capitol Concourse" regarding electrical outlet use by vendors, and to create new procedures to determine the amount of equipment merchant vendors may use to update the Mall/Concourse vending site map, and to authorize the VOC to approve future changes to the map.

Amending Sections 9.13(6)(j)1.b. and 9.13(6)(j)4. of the Madison General Ordinances regarding placement of merchant vendor equipment on the State Street Mail/Capitol Concourse and Section 9.13(6)(I)2. of the Madison General Ordinances regarding vendors' use of electrical outlets.

This matter was RECOMMEND TO COUNCIL TO ADOPT (15 VOTES REQUIRED) - REPORT OF OFFICER. The motion passed.

Action Item: 9.13(5), 9.13(6)(j)2. Updates to Citywide standards for sidewalk cafe placement and eligibility; 9.13(6)(j)1, 9.13(6)(i). Delete references to "sparkle light poles."

Schenkel suggested that Mainella draft appropriate revised language. All present agreed.
