Suspension of rules – event sponsor requests suspension of the “homemade/handcrafted” vending rules in the Mall/Concourse area.

Selection of vendors - authorizes event sponsors to select vendors for the event and requires they obtain a Special Event Vending License

Invalidation of vending licenses – licensees with assigned sites inside the event perimeter cannot operate from the assigned site during the event, unless specifically exempted.
