Dear Plan Commission, Because of previous commitments, we are unable to attend this weeks hearing concerning the conditional use permit application for an outdoor eating area at the South Bay Lounge, 5404 Raywood Road, we wanted the City Plan Commission to be aware of our concerns. We attended the June 18th hearing to express our opposition and concerns of the outdoor eating area in a residential neighborhood and the Waunona Neighborhood Association Annual Meeting on June 28th to further express our position. As a long time resident on Frazier Ave. since 1969, we have co-existed peacefully with the tavern and the various owners and would like to continue with David Arms as a responsible business neighbor.

We have listed our suggestions below:

- 1) Monitor patio capacity to prevent overcrowding;
- 2) Keep side door to parking lot closed;
- 3) Monitor patron conduct in parking lot and on patio;
- 4) No outdoor amplified sound be permitted for the outdoor eating area;
- 5) That operation of the outdoor eating and drinking area cease at 10pm daily;
