RE: Chief of Police Security Plan

Dear Mr. Schiavo:

Pursuant to the provisions of Section 38.07(13), Madison General Ordinances, the following Chief's Security Plan is herewith imposed upon the premises known as Club Majestic, 115 King Street, Madison, Wisconsin. The elements of this security plan are now conditions of your alcohol beverage license. Violation of any of your license conditions may result in prosecution for an ordinance violation, the assessment of demerit points against your alcohol beverage license, and the assessment of a monetary penalty upon conviction of an ordinance violation.

The Chief's Security Plan is as follows:

1. The patron capacity of Club Majestic shall be two hundred (200). At 1:00 a.m. each morning the patron capacity of Club Majestic shall be reduced to one hundred and fifty (150). You must use counting devices to maintain an accurate count of you patron capacity. Patron counting devices must be made available to Madison Police upon request.
2. Club Majestic must have one (1) security person for every thirty (30) patrons. All security personnel shall wear conspicuous clothing that readily identifies them as security for the establishment. The word "Security" shall be provided on the back of any shirt or jacket and shall be in a color that contrasts with the shirt or jacket color. By September 20, 2006, Club Majestic shall provide the Central Police District Captain with a photograph showing the shirt/jacket (front and back) that Club Majestic security personnel will be wearing.

3. No beverages of any kind may be served to patrons in a glass bottle.
4. Any entertainment at Club Majestic, including disc jockeys and amplified music, must end one hour before the statutory bar time each night.

If you object to this Chief's security plan, pursuant to Sec. 38.07(13), Madison General Ordinances, you have ten (10) days from the date of this plan to object to the Chief of Police and the City Clerk. If you timely object, a hearing will be held before the Alcohol License Review Committee.

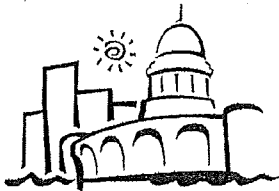
A copy of your new liquor license, which shows the above plan elements as conditions on your license, is attached and is effectively immediately.

RE: **Amended** Chief of Police Security Plan

Dear Mr. Schiavo:

Pursuant to the provisions of Section 38.07(13), Madison General Ordinances, the following Amended Chief of Police Security Plan is herewith imposed upon the premises known as Club Majestic, 115 King Street, Madison, Wisconsin. This amendment is made pursuant to Club Majestic's immediate voluntary surrender of its Center For The Visual And Performing Arts license.

The elements of this security plan are now conditions of your alcohol beverage license. Violation of any of your license conditions may result in prosecution for an ordinance violation, the assessment of demerit points against your alcohol beverage license, and the assessment of a monetary penalty upon conviction of an ordinance violation.

The Chief's Security Plan is as follows:

1. The patron capacity of Club Majestic shall be two hundred (200). At 1:00 a.m. each morning the patron capacity of Club Majestic shall be reduced to one hundred and fifty (150). You must use counting devices to maintain an accurate count of you patron capacity. Patron counting devices must be made available to Madison Police upon request. This condition applies only to those times when Club Majestic is operating as a tavern. This condition will not be in force during theatrical productions which are defined as any dramatic or musical productions for the stage and/or screen to which entrance money is received in exchange for admission to the production (e.g. plays, comedy acts, music concerts and performances of that nature).



2. Club Majestic must have one (1) security person for every thirty (30) patrons. All security personnel shall wear conspicuous clothing that readily identifies them as security for the establishment. The word "Security" shall be provided on the back of any shirt or jacket and shall be in a color that contrasts with the shirt or jacket color. By October 2, 2006, Club Majestic shall provide the Central Police District Captain with a photograph showing the shirt/jacket (front and back) that Club Majestic security personnel will be wearing. . This condition applies only to those times when Club Majestic is operating as a tavern. This condition will not be in force during theatrical productions which are defined as any dramatic or musical productions for the stage and/or screen to which entrance money is received in exchange for admission to the production (e.g. plays, comedy acts, music concerts and performances of that nature).
3. No beverages of any kind may be served to patrons in a glass bottle.
4. Any entertainment at Club Majestic, amplified music included, must end one hour before the statutory bar time each night.

Sec. 38.07(13), Madison General Ordinances provides an appeal process for the imposition of a Chief of Police Security Plan. Based upon the exceptions provided by Chief Wray in elements 1 and 2 of the Chief's Security Plan, Club Majestic, through its attorney, Victor Arellano, has agreed to waive any right to appeal this Chief's Security Plan.

A copy of your new liquor license, which shows the above plan elements as conditions on your license, is attached and is effectively immediately.
