
Greetings:

The above mentioned matter was scheduled for an initial appearance in Madison Municipal Court on June 14, 2010, at 10:30 a.m. Pursuant to our agreement, I have asked the court to impose a total forfeiture of \$18,951 (\$15,000 forfeiture, \$3,900 penalty assessment, \$51 court costs) due to the court in monthly installments beginning September 1, 2010.

Consequently, your client is to begin making monthly installments of \$238.10 beginning September 1, 2010, to the Madison Municipal Court, Room 203, City-County Building, Madison, WI 53703. Please have your client make the checks payable to Madison Municipal Court and also include the above Court Case Number on the check.

Seventh Hundred-Fifty (750) points will be assessed for these violations.

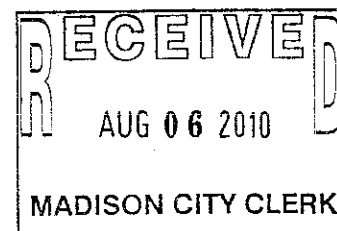
