# Feedback from Providers about current system

- Dedicated City service increased longevity and quality
- Ability to have needs addressed locally
- Value of feeling appreciated by the City
- Focus on serving children who are excluded or asked to leave other programs

- Need for clarity in the process
- Annual accreditation is burdensome on provider time and budget
- Length of accreditation process can vary
- Left feeling unsure of next steps
- Definition of religious bias is unclear

## Child Care Accreditation System Changes

Exploring accreditation process changes

- 3 Year Accreditation Cycle
  - Initiated by program
  - Annual reports
  - Child Care Program Specialist assignment Changes
  - Technical Assistance available before and after accreditation process
  - Clear schedules and timelines for accreditation
  - Lessen required meeting and classroom observations
  - Accreditation expires 3 years after accreditation is awarded

## Child Care Accreditation System Changes

Accreditation Systems

- Electronic File Sharing
- Plain language tools, guidance and standards

Funding and Eligibility Criteria

- Require programs or agencies not previously accredited by the City to earn a 3 Star rating prior to beginning accreditation services
- Redefining eligibility, timelines and criteria for grant funding
- Focus on highest needs

**Tuition Assistance Program** 

- Assessment of community need Child Care unit specific ordinances
- Review, develop and recommend new ordinances

### City of Madison Child Care Standards Revision

#### City of Madison Child Care Standards Revision

- Align with National Association for the Education of Young Children (NAEYC) and YoungStar Evaluation Criteria
- Eliminate duplication with regulatory agencies where able
- Infuse City of Madison values
- Critical lens on suspension, expulsion and inclusionary practices
- Develop standards that are clear to experienced staff and individuals entering the workforce
- Support for diverse families, abilities, children and providers
- Technical assistance and guidance documentation for providers

## City of Madison Child Care Accreditation Standard Example

F-2b. (pg 20.) Written policies promote healthy practices that reduce the risk of preventable disease in both children and adults in the program. Program practices include:

- Serving healthy meals that include fruits and vegetables, whole grains, meat and meat alternatives.
- Celebrating special occasions (e.g. holidays, birthdays) by offering nutritious snacks and doing creative activities that focus on the reason for the celebration.
- Limiting beverages to milk, water, and juice (if desired) on an occasional basis.
- Providing family style meal service.
- Planning and providing daily physical activity (per recommendations of the American Academy of Pediatrics), including daily outdoor play as weather permits.
- Staff modeling of healthy eating and physical activity, and avoiding consumption of unhealthy foods and beverages in front of children.

City Services include a provider commitment to meeting City of Madison Standards or other high-quality pathways



#### **Current:**

- Internal review of City of Madison Accreditation Standards
- Determining effective services to align with community needs and City of Madison budget

#### May-June 2024

- Finalize Draft Standards for public input
- Conduct information and feedback gathering sessions
- Finalize accreditation of programs not accredited in 2023-2024
- Develop Accreditation process materials
- Provide training and outreach to currently accredited providers

#### July 2024-January 2025

- Present Ordinance change recommendations to the Early Childhood Care and Education Committee
- Provide currently accredited programs official accreditation dates
- Department of Children and Family approval for City of Madison Child Care Accreditation Standards
- Present finalized City of Madison Accreditation Standards to ECCEC
- Resolution changes to the Common Council
- Communicate provider expectations and provide training on new systems
