The Chair reviewed the request of the Water Utility Board to provide a recommendation on the continuation of the current fluoride policy issued by Public Health Madison and Dane County. Zahner called attention to the second to last paragraph of the department policy statement supporting and recommending water fluoridation using the optimum fluoride concentration of 1ppm as recommended by the CDC and World Health Organization. Cnare, as a member of both this Board and the Water Utility Board, felt it important that the public be heard and experts in this area be invited to speak to the Board of Health on this issue.

#### **Invited Presentations**

Margaret Pfeffer Wisconsin Oral Health Program

She provided a handout from the Division of Public which was a statement on community water fluoridation, including a summary that it is the most efficient way to prevent tooth decay.

#### Timothy Koob

Dr. Koob is president of the Dane County Dental Society. He and another dentist, Eric Teduits, who practices pediatric dentistry, spoke to endorse fluoridation. Both of them are familiar with the studies and articles on the benefits, cost effectiveness, and the efficient help fluoridated water provides across all economic groups. The American Dental Association, Wisconsin Dental Association, American Medical Association and World Health Organization all support fluoride in the water.

#### Jeff Lafferty

The process used to develop the policy statement was to provide information to the public using a non-biased approach. It was initiated by calls and inquiries and put together to provide information to the public. This is a cost effective intervention that reaches all parts of the community. The policy was reviewed by Dr. Tom Schlenker, internal and external experts. With 50 years of data on fluoride it was deemed that the pros outweigh the cons.

#### 3. PUBLIC COMMENT - 3 minutes per speaker

Jason Lowrey – This speaker opposes the fluoride policy and believes people should have a choice. The safety issue is questionable. He made the point to be careful about the data you are looking at and consider that more research is needed on the correlation of effectiveness of fluoridation of the water supply.

Patrick Tepe - He is a practicing Dentist in Verona that supports the current fluoride policy. He finds more people drinking bottled water for different reasons and has seen an increase in tooth decay.

Steve Books – He questioned the chemical make-up of fluoride, opposes extra water fluoridation noting that toothpaste has fluoride.

Carson Young – He opposes the fluoridation policy. Fluoridation gave him severe eye problems after moving to Madison in 1948. He provided a handout to support his opinion.

Gary Cohen – He opposes the fluoride policy and provided a handout for Board members. He points out in the handout several publications to review including the journal Fluoride. This journal covers all biomedical aspects of research on fluoride but is still being excluded from US Public Health Service's National Library of Medicine in lists of journals indexed.

Bruce Rideout – He opposes the fluoride policy. He provided a handout referencing publications by Roger Masters, a scientist at Dartmouth. Fluoride contains toxic chemicals, some the same as used in rat poison. He feels there is a profit motive to fluoridating water.

#### 1. Thank You Letter to Donna Vogel

Zahner reports that she wrote a thank you letter to Donna Vogel thanking her for her service on the Board. No replacement to the Board has been made.

#### 6. DIRECTOR'S REPORT - Tom Schlenker - 5 minutes

Schlenker had a travel problem so he communicated his report through the Chair. The department received a grant from St. Mary's and Dane County Medical Society to show the video on infant mortality. In the next week or two, there should be an article in Newsweek magazine on infant mortality, and the video will be on the Newsweek website. The department's H1N1 team is doing a wonderful job. Kim Neuschel and Jessica LeClair, PHNs working in Meadowood, are getting notice for their ongoing work in Meadowood.

#### 7. ENVIRONMENTAL HEALTH DIVISION REPORT - Tommye Schneider - 5 minutes

Schneider reported on the incredible work and progress in the H1N1 planning done by using the incident command system learned through emergency preparedness work. School clinics will begin next week if the vaccine arrives and continue through approximately the end of November. A mass clinic is being planned in conjunction with MATC. Contractors have been lined up, staffing for the clinics identified and we await the vaccine from the state. She is very proud of the work staff has done. The Safe Food Advisory Committee continues their good work helping determine an on line inspection posting.

## 8. FAMILY/COMMUNITY HEALTH & POPULATION HEALTH DIVISIONS - Janel Heinrich - 5 minutes

Heinrich echoed the incredible job that staff is doing given the time demands for H1N1 planning. A small clinic exercise was held yesterday afternoon with the clinic team participating in various roles. Zahner mentioned UW School of Nursing voted to support the effort and will be volunteering. Sonzogni asked if there is anything the Board could do, recognizing that business as usual will not happen during this time with H1N1 clinics ongoing. A designated staff person will be working with special populations, which includes the homeless population.

#### 9. OPERATIONS DIVISION REPORT - David Caes - 5 minutes

Caes reports that the resolutions for information only are contracts with the state for Phases 1-3 of the Public Health Emergency Preparedness grants. This money is already spent and in fact, it will cost approximately \$2,000,000 to run the clinics.

AIDS Support Network funding has moved from the public health budget to the Office of Community Services. There were no amendments to the capital budget. The report today was that unions and the county are close to a contract agreement for next year. At the Board of Estimates meeting, there was a pleasant response to the anti-violence initiative in the Meadowood neighborhood. A joint meeting of the County Personnel and Finance and City Board of Estimates will take place October 19 at 6:00 p.m. in CCB, Room 309. Other agencies have really stepped forward to help with H1N1 planning, i.e. Information Technology, City Attorney and Document Services.
