A. APPROVAL OF MINUTES - January 26, 2010

A motion was made by Compton, seconded by Crandall, to Suspend the Rules to take item D.2. out of order. The motion passed by voice vote/other. Item D.1. was taken out of order following D.2.

C. MADISON POLICE DEPARTMENT REPORT ON TRAFFIC RELATED ISSUES

C.1. 17469 Madison Police Department Traffic Reports, fourth quarter 2009

There were 4,594 traffic citations issued in the fourth quarter of 2009, 1,203 of which were issued by the Traffic Enforcement Safety Team. This represents a

7% decrease in traffic citations issued department wide and a 14% increase in citations issued by the Traffic Enforcement Safety Team in the fourth quarter of 2009 compared to the fourth quarter of the previous year.

The Police Department received a speed enforcement grant, pedestrian grant, and bicycle grant. The Police Department will also receive a new speed board as part of the speed enforcement grant.

D. NEW BUSINESS

D.1. 17472 Discussion on Adult School Crossing Guard Program

At the January meeting, PBMVC requested to receive additional information including a map of the current Adult School Crossing Guard assignments, history of assignments and assessments. The requested information was provided to PBMVC members for this meeting to discuss. Patti Knoche, west side crossing guard supervisor, and Lt. Bitterman from the Police Department attended to answer questions.

Compton stated that she would like to discuss this item in more depth after having some time to review the information on current crossing guard assignments and go to various locations in the city to observe those locations. Webber asked how new locations get considered for an Adult School Crossing Guard. Staff stated that requests for crossing guards initiate from the schools. The principal should receive comments from parents and the public regarding such requests, and will contact Traffic Engineering with requests to study specific locations for an Adult School Crossing Guard.

Compton suggested that the City survey the schools to more proactively identify location needs rather than being solely request driven. Holloway asked if guards are removed from locations when the location no longer warrants a need. Staff stated that ASCG locations that meet the adopted criteria for discontinuance are recommended for discontinuance, but that those recommendations often are not acted on. Webber suggested that Compton and Maniaci work together to identify specific aspects of the Adult School Crossing Guard assignment process for future discussion.

D.2. 17473 University Avenue & Campus Drive Intersection Reconstruction Assessment District - 2010

Chris Petykowski from Engineering, and Scott Langer from Traffic Engineering, presented the proposed intersection reconstruction project at University Avenue and Campus Drive. Alder Bidar-Sielaff attended the discussion.

Changes include narrowing lanes to slow traffic, larger islands with landscaping, widening sidewalks, and adding a bike lane on University to cross Campus Drive. Webber suggested adding a bike box to the left turn lane of the northbound lane of Breese Terrace.

Bidar-Sielaff stated that the project has been shared with the neighborhood and that she has received positive comments about the project from the neighborhood and is in support.

Compton moved acceptance of the report with recommendations made by the PBMVC, seconded by Crandall. The motion passed by voice vote/other. Compton asked Petykowski to forward comments and recommendations from the PBMVC to the Board of Public Works and Council at upcoming meetings and note that the PBMVC supports the project.
