Destination Madison Report: Ellie Westman-Chin, President CEO Destination Madison and Jamie Patrick, Vice President, Madison Area Sports Commission

The resident sentiment survey was completed with 1,800 responses across all sectors of the population. They are running a special tourism campaign in Chicago for Madison. They are also happy to report that they received 2 RFPs from the familiarization (FAM) tour where Monona Terrace hosted the group's breakfast.

Overall hotel occupancy is down a little in August while average daily rate is a little up over 2023. Downtown occupancy is higher and ADR is fairly flat to last year at this time.

Destination Madison Sales team has achieved 80% of their Monona Terrace goal for Priority One events, only 12.5% for Priority Two events, and 40% of their goal for repeat conventions and conferences.

 85203 Booking Pace Update: Bill Zeinemann, Associate Director Marketing and Event Services

Event revenue is projected to be \$4.572M verses a budget of \$4.012M. This is 12% up and it doesn't even include any other events that may get booked before year end.

August revenue was higher than budget, and actual expenses were under budget. The revenue was boosted by two large events. This brings total revenue to \$425,000 higher than budgeted year to date. The expenses are anticipated to be up in September due to hourly staff needed to keep up with the events, and equipment rental costs for some of our larger events. The cost is slightly offset by salary savings from some currently open positions. The average spend per convention has increased to \$90,000 this year. When forecasting, staff use historical averages to determine revenues.

The east dock sump pump came in and was installed to replace the broken one. The west dock pump should be and installed before end of the month.

Ad agency Heibing is working on the wedding testimonial video.

Two new guest services attendants, an hourly operations worker, a full-time operations worker, a gardener and a maintenance mechanic were hired.
