COMPLAINING WITNESS

Kelly Way

The above-named complaining witness being first duly sworn states the following:

Count 1: OPERATE MOTOR VEHICLE AFTER REVOCATION - 4TH AND SUBSEQUENT OFFENSE

The above-named defendant on or about Monday, March 31, 2008, in the City of Fitchburg, Dane County, Wisconsin, while being a person whose operating privileges had been revoked pursuant to the Laws of the State of Wisconsin did operate a motor vehicle on a highway during such revocation or thereafter, and the defendant knew his operating privilege had been revoked, contrary to sec. 343.44(1)(b), 343.44(2)(b) Wis. Stats., a Misdemeanor, and upon conviction shall be fined not more than Twenty Five Hundred Dollars (\$2,500), or imprisoned for not more than one (1) year in the county jail, or both.

And the Court shall revoke the defendant's operating privileges upon conviction for six (6) months, unless the court orders a period of revocation of less than 6 months and places its reasons for ordering the lesser period of revocation on the record.

FACTS:

Your complainant has read the official law enforcement agency reports prepared by City of Fitchburg Police Department Police Officer Jeffrey Wissink, said reports having been prepared, filed, and maintained in the normal and ordinary course of business of said law enforcement agency. According to said reports, on the above-stated date, at 9:46 am, Officer Wissink personally observed an individual, who was identified with a United States passport as the above-named defendant, operating a motor vehicle at Syene Road and Irish Lane, in the City of Fitchburg, Dane County, Wisconsin.
