Contract 9305 and Project 14619 are for the construction and restoration of public improvements necessary to serve the redevelopment at 131 W Wilson Street. A certified survey map is required and the site will be re-addressed to 133 W Wilson Street. Public improvements include construction of 8' terrace, 5' sidewalk, 1' buffer strip, curb & gutter, and pavement restoration on W Wilson Street. One private drive apron will be constructed to access the property from W Wilson Street. New private sanitary, storm, and water service laterals will be constructed to serve the new building. New street terrace trees will be planted per City Forestry approval. The developer will be required to coordinate work with the City's pending W Wilson Street reconstruction project.

The 4649 Verona Road project (contract 9231) was previously before the Board and approved at their November 2, 2022 meeting. Since that approval the Madison Sanitary Sewer Utility has requested that the developer perform additional off-site sanitary sewer work to remedy an existing condition where the existing sanitary sewer is located under an existing retaining wall. The Madison Sewer Utility will reimburse the actual cost of this additional work up to \$25,000.00. Additional, street geometric design changes have been required to accommodate the necessary stormwater management measures

needed to treat stormwater runoff from the Atticus Way extension. The stormwater management measures will be located in the street terrace on the north side of Atticus Way. This design change will also result in the removal of one existing street terrace tree to the east of the original project limits.

The bid alternate included provided and installation of a backup generator which will provide continuous power to the lift station in the event of a loss of power. This work was separated from the overall project scope due to the project coming in way over the anticipated bid in 2022. The winning alternate bid for the generator work is comparable to what the City has been paying for generators with the City-wide Pumping Stations-Emergency Stationary Generator program. The estimated bid for the alternate was \$60,000 and the Speedway bid was \$31,000 for the generator.
